
6 Be it ordained by the People of the City and County of San Francisco:

7 Section 1. Article 7.1 of the San Francisco Police Code is hereby amended by  
8 amending Section 507.1, to read as follows:

9 **Sec. 507.1 RETIREMENT OF HORSES BY CARRIAGE HORSE OWNERS.** It is the policy  
10 of the City and County of San Francisco that all horses retired from serving as carriage horses  
11 in the City and County of San Francisco be treated humanely. Horse carriage operators shall  
12 make reasonable efforts to place retired carriage horses in a humane location and shall  
13 ensure their humane treatment in retirement. Such reasonable efforts shall include adoption  
14 placements by horse carriage operators and agreements with horse sanctuary organizations  
15 for the humane placement and continual humane treatment of retired carriage horses.




