8 WHEREAS, The Chief of Police of the City and County of San
9 Francisco has undertaken a certain project designated the "California
10 Cold Hit DNA Program," to be funded from funds made available through
11 the Office of Criminal Justice Planning (herein referred to as OCJP);
12 and,

13 WHEREAS, due to other demands, available biological evidence
14 submitted from suspectless crimes has not been examined routinely by
15 the San Francisco Crime Lab; and,

16 WHEREAS, this program will provide funding to conduct DNA
17 analysis of a backlog of evidence from unsolved sexual assaults and
18 homicides with sexual component; and,

19 WHEREAS, The Department proposes to maximize use of available
20 grant funds on program expenditures by not including indirect costs
21 in the grant budget; now, therefore, be it

22 RESOLVED, That the Chief of Police of the City and County of San
23 Francisco is authorized on behalf of the City and County of San
mlr 2/7 24 Francisco to accept/^{retroactively}~~and expend~~ continued funding for this project

4 inclusion of indirect costs in the grant budget; and be it


5 FURTHER RESOLVED, That the Chief of Police is authorized to
6 execute on behalf of the City and County of San Francisco the
7 necessary Grant Award Agreement for this project including any
8 extensions, funding augmentations from OCJP, or amendments thereof;
9 and be it

10 FURTHER RESOLVED, That it is agreed that any liability arising
11 out of the performance of this Grant Agreement, including civil court
12 actions for damages, shall be the responsibility of the grantee and
13 the authorizing agency. The State of California and OCJP disclaim
14 responsibility for such liability; and be it

15 FURTHER RESOLVED, That funds received hereunder shall not be
16 used to supplant expenditures controlled by this body, and be it

18 positions created under the proposed grant as "G", or grant-funded positions.




