3 **Ordinance amending San Francisco Transportation Code, Division I, Article 7 (Transit**  
4 **Violations) Sections 7.2.101 and 7.2.104 to eliminate restrictions on rear exit boarding**  
5 **of Municipal Railway transit vehicles in revenue service and clarify that failure to tag a**  
6 **Clipper Card transponder or card reader is a violation of Section 7.2.104; and making**  
7 **environmental findings and technical corrections.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. The Planning Department has determined that the actions contemplated in  
13 this ordinance comply with the California Environmental Quality Act (California Public  
14 Resources Code Section 21000 et seq.). Said determination is on file with the Clerk of the  
15 Board of Supervisors in File No. 120317 and is incorporated herein by reference.

16 Section 2. Article 7 of the San Francisco Transportation Code is hereby amended by  
17 amending Sections 7.2.101 and 7.2.104, to read as follows:

18 **SEC. 7.2. INFRACTIONS.**

19 In addition to public offenses created by the Vehicle Code, the actions listed in this  
20 Section 7.2 are prohibited, and each and every violation of a prohibition listed below shall be  
21 an infraction, except as otherwise provided in: (a) this Code; or (b) the Vehicle Code; or (c) as  
22 necessary to comply with the direction of a Police Officer or Parking Control Officer; or (d) with  
23 respect to a Municipal Parking Facility, upon the direction of an authorized parking attendant;  
24 or (e) with respect to any other Public Property, except with the permission of, and subject to  
25

1 such conditions and regulations as are imposed by the agency that owns the property that are  
2 available for public inspection at the agency's offices.

3 **SEC. 7.2.101. FARE EVASION REGULATIONS.**

4 (a) For any passenger or other person in or about any public transit station (including  
5 an outdoor high-level boarding platform or station operated by the Bay Area Rapid Transit  
6 District), light rail vehicle, streetcar, cable car, motor coach, trolley coach or other public transit  
7 vehicle to evade any fare collection system or proof of payment program instituted by the  
8 Municipal Transportation Agency.

9 (b) For any person to board or ride a light rail vehicle, streetcar, cable car, motor coach,  
10 trolley coach without prior or concurrent payment of fare.

11 (c) ~~For any person to board a streetcar, motor coach, trolley coach through the rear exit  
12 except: (i) when a representative of the transit system is present at such exit for the collection of fares  
13 or transfers or the inspection for proof of payment; (ii) when the streetcar, motor coach, trolley coach  
14 or other transit vehicle is operating at a station or boarding platform where fares are collected prior to  
15 boarding the transit vehicle; (iii) when necessary for access by persons with disabilities on wayside  
16 boarding platforms; (iv) when the streetcar, motor coach, or trolley coach is operating in a Proof of  
17 Payment Zone; or (v) on lines, routes or at locations designated by the SFMTA.~~

18 (d) To fail to display a valid fare receipt or transit pass at the request of any authorized  
19 representative of the transit system or duly authorized peace officer while on a transit vehicle  
20 or in a Proof of Payment Zone.

21 (e) To misuse any transfer, pass, ticket, or token with the intent to evade the payment  
22 of any fare.

23 (f) To knowingly use or attempt to use any illegally printed, duplicated, or otherwise  
24 reproduced token, card, transfer or other item for entry onto any transit vehicle or into any  
25 transit station with the intent of evading payment of a fare.

1           (gf) For any unauthorized person to use a discount ticket or fail to present, upon  
2 request from a system fare inspector, acceptable proof of eligibility to use a discount ticket.  
3 (127)

4 **SEC. 7.2.104 CLIPPER CARD REGULATIONS.**

5           (a) To fail to display a valid Clipper card at the request of any authorized  
6 representative of the transit system or duly authorized peace officer while on a transit vehicle  
7 or in a Proof of Payment Zone.

8           (b) To misuse any Clipper card with the intent to evade the payment of any fare, or  
9 to fail to tag a Clipper card transponder or card reader while on a transit vehicle or in a Proof of  
10 Payment Zone.


11           (c) To knowingly use or attempt to use any illegally printed, duplicated, or otherwise  
12 reproduced Clipper card for entry onto any transit vehicle or into any transit station with the  
13 intent of evading payment of a fare.

14           (d) For any unauthorized person to use a discount Clipper card or fail to present,  
15 upon request from a system fare inspector, acceptable proof of eligibility to use a discount  
16 Clipper card.

17           Section 3. Effective Date. This ordinance shall become effective 30 days from the  
18 date of passage.

19  
20           Section 4. This section is uncodified. In enacting this Ordinance, the Board intends to  
21 amend only those words, phrases, paragraphs, subsections, sections, articles, numbers,  
22 punctuation, charts, diagrams, or any other constituent part of the Transportation Code that  
23 are explicitly shown in this legislation as additions, deletions, Board amendment additions,  
24 and Board amendment deletions in accordance with the "Note" that appears under the official  
25 title of the legislation.

LEGISLATIVE DIGEST

[Transportation Code - Fare Evasion and Clipper Card Regulations]

**Ordinance amending the San Francisco Transportation Code, Division I, Article 7 (Transit Violations) Sections 7.2.101 and 7.2.104 to eliminate restrictions on rear exit boarding of Municipal Railway transit vehicles in revenue service and clarify that failure to tag a Clipper card transponder or card reader is a violation of Section 7.2.104; and making environmental findings and technical corrections.**

Existing Law

Under current law, Municipal Railway passengers are prohibited from boarding a street car, motor coach, or trolley coach through the rear exit except when:

- a Municipal Railway representative is present at the exit to collect fares or transfers, or inspect proof of payment;
- the transit vehicle is operating at a station or boarding platform where fares are collected prior to passengers boarding the vehicle;
- necessary for persons with disabilities to board;
- the transit vehicle is operating in a Proof of Payment Zone; or
- the SFMTA has indicated that rear exit boarding is permitted on a designated transit line, route or location.

In addition, the misuse of any Clipper card with the intent to evade the payment of any fare is a violation of existing Clipper card regulations.

Amendments to Current Law

This ordinance eliminates existing restrictions on rear exit boarding of Municipal Railway transit vehicles in revenue service, and clarifies that failure to tag a Clipper card transponder or card reader is a violation of Section 7.2.104.

Background Information

The SFMTA seeks to permit Municipal Railway passengers to board transit vehicles from the rear exit in order to speed up passenger boardings, increase on-time performance levels, and reduce travel times. Since a large percentage of customers now use Clipper cards, these passengers can utilize Clipper card transponders located near the rear exit to record payment. Random fare inspection enforcement on transit vehicles will help ensure that increased levels of fare evasion will not result. In addition, the SFMTA seeks to clarify that failure to tag a Clipper card transponder or card reader is a violation of Section 7.2.104.

RESOLUTION No. 12-063

WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA), on July 1, 2012, will become the first bus and rail provider in the United States to institute All-Door Boarding on rail vehicles and buses systemwide, permitting customers with valid fare media to enter through the rear door; and,

WHEREAS, Expediting loading through All-Door Boarding can significantly improve overall travel times and improve reliability; and,

WHEREAS, San Francisco Transportation Code Sections 7.2.101 and 7.2.104 currently address fare evasion regulations and use of the Clipper Cards and require amendments to accommodate All-Door Boarding and clarify the requirements for when to properly validate a Clipper Card; and,

WHEREAS, Amending San Francisco Transportation Code Section 7.2.101 would eliminate existing restrictions on rear-door boarding of Municipal Railway transit vehicles in revenue service; and,

WHEREAS, Amending San Francisco Transportation Code Section 7.2.104 would clarify that failure by customers to tag a Clipper Card transponder or card reader upon boarding is a violation; and,

WHEREAS, It has been determined that the proposed change to eliminate restrictions on rear exit boarding of Municipal Railway transit vehicles in revenue service, and require customers to tag their Clipper cards on card transponders or readers upon boarding an SFMTA transit vehicle or entering through a station fare gate is not subject to environmental review because these activities will not result in a direct or reasonably foreseeable indirect physical change in the environment pursuant to Title 14 of the California Code of Regulations section 15060(c)(2) that; and

WHEREAS, Said CEQA determination is on file with the Secretary to the SFMTA Board of Directors and are incorporated herein by this reference; now, therefore, be it

RESOLVED, Recommending that the Board of Supervisors approve amendments to San Francisco Transportation Code, Division I, Article 7 (Transit Violations), Section 7.2.101 to eliminate restrictions on rear exit boarding of Municipal Railway transit vehicles in revenue service, and Section 7.2.104 to clarify that failure to tag a Clipper Card transponder or card reader is a violation in order to support the implementation of All-Door Boarding.

The San Francisco Municipal Transportation Agency respectfully requests that this Ordinance be heard at the earliest possible meeting of the San Francisco Board of Supervisors.



Subject: Request to Amend San Francisco Transportation Code, Division I, by amending Sections 7.2.101 and 7.2.104 to accommodate All-Door Boarding on SFMTA vehicles and clarify Clipper card regulations

The San Francisco Municipal Transportation Agency (SFMTA) requests that the Board of Supervisors approve amendments to San Francisco Transportation Code, Division I, by amending Sections 7.2.101 and 7.2.104 to accommodate All-Door Boarding on SFMTA vehicles effective July 1, 2012, and clarify that failure to tag a Clipper card transponder or card reader while on a transit vehicle or in a Proof of Payment zone with the intent to evade fare payment is a violation of Section 7.2.104.

**Background**

In July 2012, the SFMTA will become the first bus and rail provider in the United States to permit customers with valid fare media to enter through the rear door of any rail vehicle or bus systemwide. Because San Francisco has one of the highest bus boarding rates in the United States at approximately 70 customers per hour, expediting loading through All-Door Boarding can significantly improve overall travel times and improve reliability. Faster service will improve the customer experience and enable the SFMTA to reinvest its existing resources into better frequency and increased capacity.

To facilitate fare payment, the SFMTA has also adopted the Clipper card, a regional smart card that can store passes, transfers, and other fare products as well as an electronic cash account. To ensure that Clipper card fares are properly processed, customers must tag a transponder or card reader upon boarding an SFMTA transit vehicle or entering through a station faregate. Failure to tag may result in the SFMTA not receiving the appropriate fare revenue for a ride taken.

**Proposed Legal Changes to Accommodate All-Door Boarding**

Under current law, Muni customers are prohibited from boarding a streetcar, motor coach, or trolley coach through the rear exit except when:

- An SFMTA representative is present at the exit to collect fares or transfers, or inspect proof of payment;

- the transit vehicle is operating at a station or boarding platform where fares are collected prior to passengers boarding the vehicle;
- necessary for persons with disabilities to board;
- the transit vehicle is operating in a Proof of Payment Zone; or
- the SFMTA has indicated that rear exit boarding is permitted on a designated transit line, route or location.

This ordinance would eliminate existing restrictions on rear-door boarding of Muni transit vehicles in revenue service as long as customers have valid proof-of-payment.

In addition, this ordinance would clarify that the failure to tag a Clipper card transponder or card reader while on a transit vehicle or in a Proof of Payment zone with the intent to evade fare payment is a violation of Section 7.2.104.
