RECOGNIZING THE SAN FRANCISCO COLLABORATIVE ORGANIZED TO PREVENT ABUSE AND ITS PARTICIPATING AGENCIES: MEN OVERCOMING VIOLENCE, SAN FRANCISCO NEIGHBORHOOD LEGAL ASSISTANCE FOUNDATION AND THE HEALTH PROMOTION SECTION OF THE DEPARTMENT OF PUBLIC HEALTH, FOR THEIR EFFORTS TO FURTHER COMMUNITY BASED PREVENTION OF INTIMATE PARTNER VIOLENCE THROUGH THEIR DOMESTIC VIOLENCE PREVENTION FRAMEWORK.

WHEREAS, It is estimated that one-fourth to one-half of all women will be assaulted by an intimate partner during their lifetime; and

WHEREAS, In San Francisco over the last ten years, 911 domestic violence calls have ranged between 8,000 and 9,600 annually; and

WHEREAS, Domestic Violence has been the number one cause of solved female homicides in San Francisco since 1981; and

WHEREAS, The Violence Prevention Network has produced a framework for violence prevention, resulting from a three year process of community organizing, which enhances San Francisco's existing coordinated citywide response; and

WHEREAS, The framework addresses three root causes and six community risk factors associated with violence; and

WHEREAS, The San Francisco Collaborative Organized to Prevent Abuse has added to this framework by addressing the root causes and community risk factors as they pertain to intimate partner and family violence; and

SUPERVISOR, KAUFMAN, BIERMAN, KATZ, NEWSOM BOARD OF SUPERVISORS

WHEREAS, In addition to addressing these causes and risk factors in general, tailoring prevention efforts to the specific ways in which families are affected may more efficiently end family violence; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco recognizes the San Francisco Collaborative Organized to Prevent Abuse and its participating agencies: Men Overcoming Violence, San Francisco Neighborhood Legal Assistance Foundation and the Health Promotion Section of the Department of Public Health, for their efforts to further community based prevention of intimate partner violence through their Domestic Violence Prevention Framework.
