



Investigations Bureau Organizational Chart






National statistics

Nearly a quarter of men will experience some form of sexual violence in their lifetime.




81% of women and 43% of men reported experiencing some form of sexual harassment and/or assault in their lifetime.

Mission of Special Victims Unit (SVU)

The mission of the San Francisco Police Department (SFPD) Special Victims Unit (SVU) is dedicated to investigating and addressing crimes involving some of the most vulnerable members of society. Our SVU Sergeants are highly specialized in handling cases related to domestic violence, sexual assault, child abuse, human trafficking, elder abuse (both physical and financial), internet crimes against children, and all financial crimes within the City and County of San Francisco. Their primary objective is to support survivors and ensure justice, while holding perpetrators accountable.

SVU officers receive state-mandated specialized training designed to equip them with the skills necessary to handle sensitive cases with empathy, understanding, and professionalism. They work closely with victims, providing essential resources and support throughout the investigation and subsequent legal processes.


Furthermore, the SVU collaborates extensively with other law enforcement bodies, social services, and community organizations to prevent victimization and enhance public awareness about these severe crimes. Through their unwavering pursuit of justice and advocacy for victims' rights, the SVU plays an indispensable role in protecting and advocating for San Francisco's most vulnerable populations.


Victim reporting pathways






SVU protocol for handling allegations of sex assaults



Sexual assault cases per year (compared to forcible rape only)




Sexual assault clearance breakdown

Policy and procedure changes

- **DATA ANALYSIS:** Semi Annual Report to the Police Commission on Sex Assault Evidence Kits (SAEK)
 - July 1 – December 31, 2023
 - Average turn around time for SAEK process completion – 39 days
 - Out of 154 SAEK:
 - 61 SAEK resulting in a foreign DNA Profile entered into CODIS
 - 20 SAEK had a CODIS profile match
 - 41 SAEK had NO CODIS profile match
 - 93 SAEK did NOT result in a DNA profile
- **TRAINING:** Extensive training between SFPD and our CBO partners, and outside training
- **COLLABORATION:** Regularly scheduled meetings with the stakeholders listed on prior slides
- COVID, mental health of our communities and the generations we serve have changed
- Limits on storage and use of DNA profiles ([Ordinance No. 73-22](#))
- SFPD has evolved to a more trauma-informed approach
