## ((SEC. 2.24. PUBLICATION AND FORMAT OF PROPOSED CHARTER

**AMENDMENTS.** Any proposal for amendment of the Charter which is ordered submitted to the electors by the Board of Supervisors shall be published in the official newspaper and in pamphlets to be mailed to each of the qualified electors of the City and County. Words in the text of the amendment which are proposed as additions to or substitutions for existing Charter language shall be printed in boldface type. Words in the Charter text which are sought to be deleted by the amendment shall be printed in lightface type and shall be enclosed by double parentheses. Appropriate notations explanatory of the types used in the proposals shall precede the text thereof.))
