**Subject: Appeal of Conditional Use Authorization - Proposed Project at 1850 Bryant Street**

Dear Mr. Clogan:


The Office of the Clerk of the Board is in receipt of a memorandum dated July 6, 2017, from the City Surveyor regarding their determination on the sufficiency of signatures with respect to the above-referenced appeal.

Pursuant to the appeal filing guidelines of Planning Code, Section 308.1(b), the notice of appeal shall be subscribed by either the owners of at least 20% of the property affected by the proposed conditional use or five members of the Board of Supervisors. The City Surveyor has determined that the appeal signatures represent 5.46% of the area within 300 feet of the project seeking conditional use authorization.

The appeal filing period closed at the end of the business day on Monday, July 3, 2017, and we are unable to accept any additional signatures for consideration in this filing. Therefore, the Board of Supervisors is not empowered to hear this appeal, as it does not meet the filing requirements of Planning Code, Section 308.1. Please find enclosed your check in the amount of \$578.
