13 purchases based on a capacity factor between 60 and 70 percent from July to November,  
14 upon amendment of the Long-Term Power Sales Agreement between the City and County of  
15 San Francisco and Turlock Irrigation District consistent with the Letter Agreement in Board  
16 File No. 030251.


17 Section 2. Turlock initiated the above-named dispute on October 10, 2001 and named


