
Dear Ms. Alabanza:

9 WHEREAS, Sopra Casa, LLC, is seeking the transfer of a Type-20 off-sale beer  
10 and wine liquor license to do business as Sotto Casa, located at 1351 Grant Avenue  
11 (District 3); and

12 WHEREAS, The Planning Department has verified that the area is properly  
13 zoned and recommends approval; and

14 WHEREAS, The Police Department has filed zero protests and zero letters of  
15 support with the Department of Alcoholic Beverage Control under California Business  
16 and Professions Code, Section 24013, and recommends that the Department of  
17 Alcoholic Beverage Control issue the liquor license with conditions; and

18 WHEREAS, The condition recommended by the Police Department is the  
19 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort  
20 to prevent the loitering of persons on any property adjacent to the licensed premises as  
21 depicted on the most recently certified ABC-253; now, therefore, be it

22 RESOLVED, That in accordance with California Business and Professions Code,  
23 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
24 hereby determines that the transfer of a Type-20 off-sale beer and wine liquor license to  
25 Sopra Casa, LLC, doing business as Sotto Casa, located at 1351 Grant Avenue, will

1 serve the public convenience or necessity of the City and County of San Francisco; and,  
2 be it

3 FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
4 San Francisco hereby endorses and adopts the recommendations of the Police  
5 Department listed above and recommends that the Department of Alcoholic Beverage  
6 Control issue the license with those conditions.
