9 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The Police Code is hereby amended by revising Section 2404.1, to read as  
 12 follows:

13 **SEC. 2404.1. STREET ARTIST CERTIFICATE: FEE.**

14 Pursuant to the provisions of Proposition K, adopted by the voters at an election held  
 15 on November 8, 1983, the Board of Supervisors hereby establishes the fee for a Street Artist  
 16 Certificate to be as follows: Beginning July 1, 20~~10~~21, the fee for a quarterly Street Artist  
 17 Certificate shall be ~~\$166.02~~20 and said certificate shall be valid for a period of three months  
 18 from the date of issuance; except that any person certified as a street artist pursuant to the  
 19 provisions of this Article shall have the option of purchasing for ~~\$664.08~~80 an annual certificate  
 20 valid for a period of one year from the date of issuance.

21 *Beginning with fiscal year 2013-2014*~~2022-2023~~, the Controller, without further action by the  
 22 Board of Supervisors, shall may adjust the fees set forth in this section by an amount that does not  
 23 exceed changes in the United States Department of Labor and Bureau of Labor Statistics Consumer  
 24 Price Index for San Francisco (the "Department of Labor CPI"), or a comparable appropriate  
 25 Consumer Price Index if the Department of Labor CPI is eliminated or superseded, provided that in no

1 ~~event may the adjusted fee exceed the Arts Commission's costs of administering and enforcing the~~  
2 ~~provisions of Article 24 of the Police Code (the "Street Artists Ordinance"). No later than April 15th of~~  
3 ~~each year, the Director of Cultural Affairs or his or her designee, shall submit to the Controller the~~  
4 ~~Arts Commission's current Street Artist Certificate fee schedule and any information the Controller~~  
5 ~~requests regarding the Art Commission's costs of administering and enforcing the provisions of the~~  
6 ~~Street Artists Ordinance. The Controller shall apply the price index adjustment to produce a new~~  
7 ~~certificate fee schedule for the following year. No later than May 15th of each year, the Controller shall~~  
8 ~~file a report with the Board of Supervisors and the Arts Commission reporting the new certificate fee~~  
9 ~~schedule and certifying that the certificate fees, as adjusted, do not produce revenue that exceeds the~~  
10 ~~Arts Commission costs of administering and enforcing the provisions of the Street Artists Ordinance.~~  
11 ~~Notwithstanding the procedures set forth in this Section, the Board of Supervisors, in its discretion,~~  
12 ~~may modify the fees by ordinance at any time.~~

13  
14 Section 2. Effective Date. This ordinance shall become effective 30 days after  
15 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
16 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
17 of Supervisors overrides the Mayor's veto of the ordinance.

19 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
20 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
21 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
22 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
23 additions, and Board amendment deletions in accordance with the "Note" that appears under  
24 the official title of the ordinance.
