3 **Motion appointing Robert Eaton, Gayle Geary, Catherine Ann Miller, Christopher**
4 **Ingram (residency requirement waived) and Brandon Bracamonte (residency**
5 **requirement waived), for one-year terms beginning upon the Council's first meeting, to**
6 **the Fire Code Technical Advisory Council.**

8 MOVED, That the Board of Supervisors of the City and County of San Francisco does
9 hereby appoint the hereinafter designated person(s) to serve as member(s) of the Fire Code
10 Technical Advisory Council, pursuant to the provisions of Administrative Code, Article XLII, for
11 the term specified:

12 Robert Eaton, seat 1, inaugural appointment, must be held by a property owner or
13 building manager of a building subject to the requirements of Section 1103.5.4 of the San
14 Francisco Fire Code, for a one-year term beginning upon the Council's first meeting;

15 Gayle Geary, seat 2, inaugural appointment, must be held by a non-owner tenant of a
16 building affected by Section 1103.5.4 of the San Francisco Fire Code, for a one-year term
17 beginning upon the Council's first meeting;

18 Catherine Ann Miller, seat 3, inaugural appointment, must be held by a duly authorized
19 homeowners' association representative of a building subject to the requirements of Section
20 1103.5.4 of the San Francisco Fire Code, for a one-year term beginning upon the Council's
21 first meeting;

22 Christopher Ingram (residency requirement waived), seat 4, inaugural appointment,
23 must be held by a person who holds an active C-16 fire protection contractor license issued
24 by the California Contractors State License Board (CA-CSLB), as Defined in California Code
25

1 of Regulations, Title 16, Division 8, Article 3, for a one-year term beginning upon the Council's
2 first meeting;

3 Brandon Bracamonte (residency requirement waived), seat 5, inaugural appointment,
4 must be held by a construction professional with experience in either general labor or skilled
5 trade, for a one-year term beginning upon the Council's first meeting; and, be it

6 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 7 1. The membership of the Fire Code Technical Advisory Council has a goal to be
8 representative of the diversity of the City and County of San Francisco.
- 9 2. Applicants Christopher Ingram and Brandon Bracamonte, who are not residents of San
10 Francisco, are persons with experience that uniquely qualifies them to serve on the
11 Fire Code Technical Advisory Council.
- 12 3. The Fire Code Technical Advisory Council has attempted to fill the positions, for which
13 Christopher Ingram and Brandon Bracamonte were nominated, with individuals who
14 are City residents and who have the specific experience, skills, and qualifications, but
15 has been unable to do so at this time. The Rules Committee has certified that
16 Christopher Ingram and Brandon Bracamonte, are qualified to serve on the Fire Code
17 Technical Advisory Council.
- 18 4. After exercising due diligence, the Board of Supervisors concludes that there are no
19 other possible representatives who are residents of San Francisco, who have the
20 specific experience, skills, or qualifications possessed by these applicants, and who
21 are willing to serve on the Fire Code Technical Advisory Council at this time; and, be it

22 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
23 for Christopher Ingram and Brandon Bracamonte, as is allowed in cases where no qualified
24 City residents who are willing to serve can be found, pursuant to Charter, Section 4.101(b),
25 that otherwise requires person(s) appointed to boards, commissions, and advisory bodies

1 established by legislative act of the Board of Supervisors to be resident(s) of the City and
2 County of San Francisco.
