

[FEDERAL FUNDING - HOME PROGRAM]

1 AUTHORIZING THE MAYOR OF THE CITY AND COUNTY OF SAN FRANCISCO TO
2 APPLY FOR, ACCEPT AND ADMINISTER A GRANT FROM THE U.S. DEPARTMENT OF
3 HOUSING AND URBAN DEVELOPMENT FOR A TOTAL AMOUNT NOT TO EXCEED
4 \$7,079,000 FOR THE HOME PROGRAM AUTHORIZED UNDER TITLE II OF THE
5 NATIONAL AFFORDABLE HOUSING ACT OF 1990, PUBLIC LAW NUMBER 101-625,
6 AND APPROVING THE HOME PROGRAM DESCRIPTION AS DESCRIBED IN THE 1999
7 ACTION PLAN FOR SAN FRANCISCO'S CONSOLIDATED PLAN. INDIRECT COSTS
8 ASSOCIATED WITH THE ACCEPTANCE OF THESE GRANT FUNDS WILL BE PAID BY
9 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS.

10 WHEREAS, the City and County of San Francisco is an eligible city for purposes of
11 receiving funds from the HOME Investment Partnership (HOME) Program, and has
12 received a formula allocation of Seven Million Seventy-Nine Thousand (\$7,079,000); and

13 WHEREAS, the HOME Program will be used to provide funds for the development,
14 acquisition and rehabilitation of low-income housing, in accordance with the Consolidated
15 Plan Action Plan for 1999 to be submitted to HUD on or before February 16, 1999; and

16 WHEREAS, the Mayor's Office of Housing has prepared a description of the
17 proposed use of HOME funds to carry out the goals of the City's 1999 Consolidated Plan
18 Action Plan and the Residence Element of the General Plan, and has incorporated that
19 description into the Action Plan; and

20 WHEREAS, a portion of the administrative and direct costs of administering the
21 HOME program are to be paid from the 1999 allocation; and

22 WHEREAS, the remainder of the administrative and direct costs of administering


1 the HOME program are an eligible Community Development Block Grant (CDBG) expense,
2 and will be paid from CDBG funds through the 1999 Community Development Program;
3 now, therefore, be it

4 RESOLVED, that the Mayor of the City and County of San Francisco is authorized
5 to apply for, accept and expend the HOME Program from the Department of Housing and
6 Urban Development according to the Federal Rules and Regulations for the program and
7 the Consolidated Plan Action Plan for 1999; and be it

8 FURTHER RESOLVED that the Board of Supervisors hereby approve the proposed
9 Program Description as incorporated into the Consolidated Plan Action Plan for 1999, on
10 file with the Clerk of the Board of Supervisors and incorporated herein by reference.


11 FURTHER RESOLVED that the Mayor is hereby authorized to submit




