[Accept - Expend State Grant]

1 Authorizing the Mayor's Criminal Justice Council (MCJC) to accept and
2 \$2,831,068
/17/01 2 expend funds in the amount of ~~\$2,831,103~~ from the State Board of
3 Corrections, from funds made available under Assembly Bill 1913 – known
4 as the Schiff-Cardenas Crime Prevention Act of 2000 (CPA 2000), for
5 programs and approaches that have been demonstrated to be effective in
6 reducing delinquency. as amended by the Board.

8 WHEREAS, MCJC is the lead programmatic and fiscal agency for the
9 county in administering CPA 2000, which provides funds for the county to
10 implement a comprehensive multi-agency juvenile justice plan; and

11 WHEREAS, CPA 2000 requires that the county's local juvenile justice
12 coordinating council, whose membership is described in Section 749.22 of the
13 Welfare and Institutions Code, update its Juvenile Justice Local Action Plan and
14 develop an expenditure plan for CPA 2000; and

15 WHEREAS, CPA 2000 also requires that the county Board of Supervisors,
16 and in the case of a city and county the Mayor, approve the updated juvenile
17 justice local action plan and the CPA 2000 expenditure plan; and

18 WHEREAS, the City originally established the Juvenile Justice
19 Coordinating Council through resolution 170-97; and

20 WHEREAS, the Chief Probation Officer, Jesse Williams, as required by
21 CPA 2000 and Section 749.22 of the Welfare and Institutions Code, serves as
22 the chair of the Juvenile Justice Coordinating Council; and

1 WHEREAS, on March 7, 2001 the Juvenile Justice Coordinating Council,
2 chaired by the Chief Probation Officer, met and recommended to the Board of
3 Supervisors the expenditure plan for CPA 2000; and

4 WHEREAS, the positions authorized under the grant are designated as "G"
5 or "Grant Funded" positions which would terminate when the grant expires; and

6 WHEREAS, all funds provided through CPA 2000 are for direct services to
7 youth, it is requested that indirect costs be waived; now, therefore, be it

8 RESOLVED, that the City and County of San Francisco hereby authorizes
9 \$2,831,068
10 MCJC to accept and expend ~~\$2,831,103~~ from the State Board of Corrections,
11 under CPA 2000 for programs and approaches that have been demonstrated to
12 be effective in reducing delinquency; and

13 BE IT FURTHER RESOLVED that the County assures that the Board of
14 Supervisors has reviewed and approves the county's Comprehensive Multi-
15 agency Juvenile Justice Plan; and

16 BE IT FURTHER RESOLVED that the Director of the Mayor's Criminal
17 Justice Council is authorized to sign the application for approval submitted to the
18 Board of Corrections; and


19 BE IT FURTHER RESOLVED that the City and County of San Francisco
20 assures that it has adhered to the requirements of CPA 2000 and of the Board of
21 Corrections regarding the submission of the plan; and

22 BE IT FURTHER RESOLVED that the plan has been developed and
23 provided to the Board of Corrections in a format determined by the Board of
24 Corrections regarding submission of the Plan; and


BE IT FURTHER RESOLVED that the City and County of San Francisco,
1 upon approval from the Board of Corrections, will adhere to the requirements of
2 the CPA 2000 regarding the expenditure of CPA 2000 funds and the submission
3 of required Board of Corrections reports; and be it

4 FURTHER RESOLVED, that the programs approved for funding through this
5 resolution are hereby amended by deleting the \$159,056 funding for the 2.3
6 FTE's 8444 Deputy Probation Officers, and transferring those funds to the
7 Intensive Home Based Supervision Program, the funds for that program now being
8 \$259,056.






