3 **Resolution enacting temporary "Street Closed to Vehicular Traffic" regulation on**  
4 **Steiner Street between Lombard and Chestnut Streets from 1:30 P.M. to 7:00 P.M. on**  
5 **every Tuesday between August 24, 2004 through September 28, 2004.**

7 WHEREAS, ISCOTT approved two temporary street closures for vehicular traffic on  
8 Steiner Street between Lombard and Chestnut Streets that covered the time period from  
9 Tuesday, May 25, 2004 through Tuesday, August 17, 2004, between 1:30 p.m. to 8:15 p.m.  
10 for a Marina Farmers Market to be held; and

11 WHEREAS, ISCOTT requested that any subsequent temporary street closure be  
12 approved by the Board of Supervisors; and,

13 WHEREAS, ISCOTT's prior approval of the temporary street closure is on file with the  
14 Clerk of the Board of Supervisors in File No. 040947, which is hereby declared to be a part of  
15 this resolution as if set forth fully herein; and,

16 WHEREAS, In order for the Marina Farmers Market to continue until September 28,  
17 2004, the Board of Supervisors must approve the temporary street closure; now, therefore, be  
18 it

19 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
20 and the San Francisco Traffic Code, the following regulation governing the movement of  
21 vehicles is hereby enacted as designated below

22 Temporary Street Closed to Vehicular Traffic, 1:30 p.m. to 7:00 pm, Every Tuesday  
23 Between August 24, 2004 through September 28, 2004, Establish  
24 Steiner Street between Lombard and Chestnut Streets.




