11	Section 1. In or about March 2008, Mayor Gavin Newsom authorized a reward of
12	\$250,000 for information leading to the arrest and conviction of the suspect or suspects
13	responsible for the April 4, 2006 murder of Willie Allen. Doe One came forward and supplied
14	information leading to the identification, arrest and conviction of the person responsible for the
15	murder of Mr. Allen. The San Francisco Police Department and San Francisco District
16	Attorney's Office have confirmed that Doe One provided investigators with information that
17	lead to the identity of the suspect responsible for the murder, and that Doe One assisted in
