SUBJECT: "Laura's Law" Implementation

The text is listed below or attached:

A hearing to review the assisted outpatient treatment for persons with severe mental illness. The hearing will discuss California's "Laura's Law" (Welfare and Institutions Code Sections 5345 et. seq.), which requires county opt-in. Since implementation of "Laura's Law" requires a county to fully fund voluntary mental programs, the hearing will also explore current funding for voluntary mental health programs. The hearing will also review studies by the New York State Office of Mental Health on assisted outpatient treatment, and guidelines established at the federal level to implement such programs.
