2 **Ordinance authorizing the settlement of lawsuit filed by Linda Novoa-Huf, Ayanda**
3 **Lumpkin and LaKreisha Crawford against the San Francisco Department Of Building**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The City Attorney is hereby authorized to settle the action entitled "Novoa-
10 Huf, et al. v. Department of Building Inspection, et al.", San Francisco Superior Court, Case
11 No. 415266, by payment of \$175,000. The sum shall be allocated as follows: a) \$100,000 for
12 Linda Novoa-Huf for general damages including emotional distress, attorney's fees and costs;
13 b) \$25,000 to Plaintiff Ayanda Lumpkin for general damages including emotional distress,
14 attorney's fees and costs; c) \$25,000 to Plaintiff LaKreisha Crawford for general damages
15 including emotional distress, attorney's fees and costs; and d) \$25,000 to Defendant Michael
16 Rodman's attorneys for their fees and costs.

18 Section 2. The above-named action was filed in San Francisco Superior Court on
19 December 3, 2002, Case No. 415266. The following parties were named in the lawsuit: Linda
20 Novoa-Huf, Ayanda Lumpkin, and LaKreisha Crawford, plaintiffs; San Francisco Department
21 Of Building Inspection, Michael Rodman, McCoy's Patrol Services, defendants.


