AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXECUTE AMENDMENT TO A DESIGN AGREEMENT FOR THE LAGUNA HONDA HOSPITAL REPLACEMENT PROGRAM FROM \$29,900,000 to \$31,533,540.

WHEREAS, the Director of Public Works has entered into an agreement dated November 20, 2000 with Anshen+Allen/Gordon H. Chong & Partners, A Joint Venture for the design of the Laguna Honda Hospital Replacement Program; and,

WHEREAS, Resolution 994-01, approved December 28, 2001, authorized the Director to enter into amendments to the agreement which when amended would not exceed \$29,900,000; and,

WHEREAS, the Director intends to increase the scope of services under said agreement and to increase the sum under said agreement to \$31,533,540; and,




