URGING THE SAN FRANCISCO WAR MEMORIAL AND PERFORMING ARTS BOARD OF DIRECTORS TO TERMINATE THE CONTRACT WITH RESTAURANT ASSOCIATES FOR FOOD CONCESSION SERVICES AT THE OPERA HOUSE, DAVIES SYMPHONY HALL AND HERBST THEATRE.

WHEREAS, In September, 1998 the San Francisco War Memorial and Performing Arts Board of Directors entered into a contract with Restaurant Associates, Inc. to operate the food concessionaires for the Opera House, Davies Symphony Hall and Herbst Theatre; and,

WHEREAS, When the contract was awarded, Restaurant Associates was informed that they must employ union members and reach a collective bargaining agreement with the Hotel Employees and Restaurant Employees Union, Local 2; and,

WHEREAS, Despite Local 2's attempt to reach an agreement,
Restaurant Associates has engaged in numerous anti-worker business
practices, terminating long term employees for such reasons as:

- ♦ Attending union meetings;
- ◆ Reporting the sexually inappropriate action of a manager;
- ◆ Contacting the Symphony director to report a patron's complaint after a manager refused to address the complaint;
- ◆ Failing to speak English well enough, although the employee has received no complaints in nine years of service; and,

WHEREAS, Restaurant Associates has established a pattern of human rights violations by dismissing workers who are union supporters, older workers, particularly older women, and people of color, as well as stifling free speech and creating an atmosphere of harassment, intimidation and discrimination; and,

WHEREAS, Local 2 has filed a complaint with the San Francisco Human Rights Commission, alleging ten counts of human rights violations by Restaurant Associates; and,

WHEREAS, The Board of Supervisors has received complaints that the level of service and quality of food at the Opera House, Davies Symphony Hall and Herbst Theatre have declined substantially since Restaurant Associates took over management of the concession; now, therefore, be it

RESOLVED, That the Board of Supervisors urges the San Francisco War Memorial and Performing Arts Board of Directors to terminate the contract with Restaurant Associates for food concession services at the Opera House, Davies Symphony Hall and Herbst Theatre.
