8 **Small Craft Harbor/Recreation and Park Department.**

9 WHEREAS, The Bay Area Air Quality Management District is authorized to provide  
10 grants to cities, counties, districts, and other public agencies to replace, repower and retrofit  
11 heavy-duty diesel engines with lower-polluting engines and retrofit control devices; and,

12 WHEREAS, The San Francisco Recreation and Park Department was awarded a  
13 grant by the Bay Area Air Quality Management District (Air District) in the amount of  
14 \$35,189.00 for the repowering (replacement) of a workboat diesel engine belonging to and  
15 operated by San Francisco Small Craft Harbor; and,

16 WHEREAS, The City and County of San Francisco is desirous of improving emissions  
17 and efficiency of the workboat currently owned and operated by the San Francisco Marina  
18 Small Craft Harbor; and,

19 WHEREAS, Equipment now in use is antiquated and requires regular and increased  
20 maintenance; and,

21 WHEREAS, By replacing with new equipment provided by this grant there should be a  
22 net decrease in annual maintenance cost, a decrease in emissions, and an increase in overall  
23 productivity of the vessel; and,

1           WHEREAS, The City and County of San Francisco is willing to enter into an agreement  
2 to provide for the operation and maintenance of the proposed facilities at no cost to the Air  
3 District; and, now, therefore, be it

4           RESOLVED, That the Board of Supervisors of the City and County of San Francisco by  
5 adoption of this resolution hereby requests that the Bay Area Air Quality Management District  
6 provide a Carl Moyer Program Grant in the amount of \$35,189.00 for the purpose of improving  
7 by repowering (replacement of) the workboat owned and operated at the San Francisco  
8 Marina Small Craft Harbor with a more efficient, lower-pollution diesel engine; and, be it

9           FURTHER RESOLVED, that the City and County of San Francisco agrees to accept  
10 the Carl Moyer Program Grant in the amount of \$35,189.00 and hereby authorizes the Board  
11 of Supervisors to sign the grant agreement and accept the grant for the purpose stated above;  
12 and, be it

13           FURTHER RESOLVED, That the City and County of San Francisco appoints the  
14 General Manager of the Recreation & Park Department as agent to conduct all negotiations,  
15 execute and submit all documents including, but not limited to applications, agreements,  
16 payment requests and so on, which may be necessary for the completion of the  
17 aforementioned project.


