19 Milton Marks III, new appointment, seat 4, must be a representative of non-profit
20 organizations involved in urban forestry or other environmentally-related issues, for a two-year
21 term ending April 5, 2005;

22 Michael Sullivan, new appointment, seat 6, must be a representative of the community,
23 for a two-year term ending April 5, 2005;

24 Juan Carrasco, new appointment, seat 7, must be a representative of the community,
25 for a two-year term ending April 5, 2005;

1 Diana Cohen, new appointment, seat 8, must be a representative of the community, for
2 a two-year term ending April 5, 2005.




