3 **Ordinance authorizing settlement of the lawsuit filed by CSAA Insurance Exchange**  
4 **against the City and County of San Francisco for \$700,000; the lawsuit was filed on**  
5 **June 17, 2014, in San Francisco Superior Court, Case No. CGC-14-539993; entitled**  
6 **CSAA Insurance Exchange v. City and County of San Francisco, et al.; the lawsuit**  
7 **involves alleged property damage arising from the break of the Public Utilities**  
8 **Commission's water transmission pipeline on 15th Avenue between West Portal**  
9 **Avenue and Wawona Street in San Francisco; and appropriating \$700,000 from the**  
10 **Water Enterprise fund balance for such purpose.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
14 authorizes the City Attorney to settle the action entitled CSAA Insurance Exchange v. City and  
15 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-14-539993 by  
16 the payment of \$700,000. The lawsuit involves alleged property damage from the break of  
17 the SFPUC's water transmission pipeline on 15th Avenue between West Portal Avenue and  
18 Wawona Street in San Francisco.

19 Section 2. The above-named action was filed in San Francisco Superior Court on June  
20 17, 2014, and the following parties were named in the lawsuit: Plaintiff: CSAA Insurance  
21 Exchange, Defendants: City and County of San Francisco and Precision Engineering, Inc.

22 Section 3. The Board herein appropriates \$700,000 from the Water Enterprise fund  
23 balance for use by the San Francisco Public Utilities Commission for purposes of settling the  
24 litigation.


