[Gift for the repair and maintenance of the Crocker Amazon football field.]

Resolution authorizing and approving a Gift from Sacred Heart Cathedral Preparatory for up to \$30,000 for renovations of the Crocker Amazon football field; and \$39,884 for the salary of a half -time gardener for one year, to be made on a monthly basis.

WHEREAS, The Crocker Amazon football field is in disrepair in large part due to gopher holes; and

WHEREAS, Given the current budget crisis the Recreation and Park Department cannot dedicate additional resources to improving the condition of the field; and

WHEREAS, Sacred Heart Cathedral Preparatory and the Junior 49ers, through standard Recreation and Park Department permitting processes, uses the field for football practice and other outdoor sports, and

WHEREAS, Sacred Heart Cathedral Preparatory would like to donate funds for the renovation of and maintenance of the field; and

WHEREAS, Sacred Heart Cathedral Preparatory understands that the Recreation and Park Department cannot give priority use or preferential treatment in return for this Gift; and

WHEREAS, Sacred Heart Cathedral Preparatory will have the right to stop monthly payments to the Recreation and Park Department for the gardener's salary if it feels that the field is not being maintained to an acceptable standard mutually agreed upon by both parties; and

WHEREAS, Sacred Heart Cathedral Preparatory will pay all necessary rental fees for weekend use, now, therefore, be it

7 Park General Manager to enter into any modifications to the Gift that the Recreation and Park
8 General Manager determines, in consultation with the City Attorney, are in the best interests
9 of the City and do not materially increase the obligations or liabilities of the City, are
10 necessary or advisable to effectuate the purposes of the Gift or this Resolution, and are in
11 compliance with all applicable laws, including the City's Charter.




