

1 [Disapprove certification of New M.H. de Young Museum EIR]

3 **Motion disapproving the certification of the Final Environmental Impact Report for the**
4 **New M.H. de Young Museum Development Project located at 75 Tea Garden Drive by**
5 **the Planning Commission.**

7 WHEREAS, The New M.H. de Young Museum (the "Project") is proposed to be
8 constructed at the museum's existing site at 75 Tea Garden Drive in the Music Concourse of
9 Golden Gate Park, Lot 1 in Assessor's Block 1700, after demolition of the eight existing
10 buildings comprising the M.H. de Young Museum and the Asian Art Museum and relocation of
11 the Asian Art Museum to its new facility in the City's Civic Center; and,

12 WHEREAS, The Corporation of the Fine Arts Museums of San Francisco submitted its
13 application for environmental review of the proposed New de Young Museum on July 12,
14 1999 (City Planning File No. 1999.455E); and

15 WHEREAS, The Planning Department for the City and County of San Francisco (the
16 "Department") determined that an Environmental Impact Report ("EIR") was required and
17 provided public notice of that determination by publication in a newspaper of general
18 circulation on May 6, 2000; and

19 WHEREAS, On July 22, 2000, the Department published the Draft Environmental
20 Impact Report ("DEIR") for the Project; and

21 WHEREAS, On August 24, 2000, the Commission held a duly noticed public hearing
22 on the DEIR, at which time opportunity for public comment was received on the DEIR, and
23 written comments were received through August 24, 2000; and

24 WHEREAS, The Department prepared responses to comments received at the public
25 hearing on the DEIR and submitted in writing to the Department, prepared revisions to the text

1 of the DEIR and published a Draft Summary of Comments and Responses on November 22,
2 2000; and

3 WHEREAS, A Final Environmental Impact Report ("FEIR") for the Project was
4 prepared by the Department, consisting of the DEIR, any consultations and comments
5 received during the review process, any additional information that became available and the
6 Draft Summary of Comments and Responses, all as required by law; and

7 WHEREAS, On December 7, 2000, the Commission reviewed and considered the
8 FEIR and, by Motion No. 16039, found that the contents of said report and the procedures
9 through which the FEIR was prepared, publicized and reviewed complied with the provisions
10 of the California Environmental Quality Act (CEQA), the State CEQA Guidelines and
11 Chapter 31 of the San Francisco Administrative Code; and

12 WHEREAS, By Motion No. 16039, the Commission found the FEIR to be adequate,
13 accurate and objective, reflected the independent judgment and analysis of the Department
14 and the Commission and that the Summary of Comments and Responses contained no
15 significant revisions to the DEIR, adopted findings relating to significant impacts associated
16 with the Project and certified the completion of the FEIR in compliance with CEQA and the
17 State CEQA Guidelines; and

18 WHEREAS, A challenge to the FEIR and the process by which the FEIR was certified
19 was brought and the San Francisco Superior Court issued a Writ of Mandamus on August 2,
20 2001 requiring the Board of Supervisors to hear an appeal of the FEIR in compliance with
21 CEQA; and

22 WHEREAS, The Board of Supervisors held a public hearing on August 20, 2001 to
23 review the decision by the Planning Commission to certify the FEIR; and


