

1 [Customer Generation Agreement - Pacific Gas and Electric Company - Solar Power Project -
2 2055 Silver Avenue]

3 **Resolution authorizing the General Manager of the Public Utilities Commission to enter**
4 **into a Customer Generation Agreement with Pacific Gas and Electric Company for a**
5 **Solar Power Project at Willie Brown Middle School at 2055 Silver Avenue, to continue**
6 **indefinitely, unless terminated.**

8 WHEREAS, The San Francisco Unified School District (SFUSD) owns and installed
9 a 133.2kW rooftop Solar Photovoltaic System (Project) at Willie Brown Middle School located
10 at 2055 Silver Avenue; and

11 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) must enter into a
12 Customer Generation Agreement—Third Party Generator on Premises Non-Exporting
13 (Agreement) with Pacific Gas and Electric Company (PG&E) in order to interconnect the
14 Project to the electrical grid; and

15 WHEREAS, The term of the Agreement is of an indefinite duration in order to ensure
16 that the Project can remain interconnected to PG&E's electrical system for its useful life,
17 which is expected to exceed ten (10) years; and

18 WHEREAS, The Agreement is subject to termination by the City for any reason upon
19 sixty (60) day's notice; and

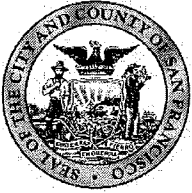
20 WHEREAS, SFUSD has agreed to reimburse the SFPUC for any charges incurred as
21 a result of the Project, including any costs associated with the Customer Generation
22 Agreement between the City and PG&E; and

1 WHEREAS, The Agreement is on file with the Clerk of the Board of Supervisors in File
2 No. 161031, which is hereby declared to be a part of this motion as if set forth fully herein;
3 now, therefore, be it

4 RESOLVED, That the Board of Supervisors authorizes the General Manager of the
5 SFPUC to enter into the Agreement with Pacific Gas and Electric Company for
6 interconnection of the Project at Willie Brown Middle School, pursuant to San Francisco
7 Charter, Section 9.118(b); and, be it

8 FURTHER RESOLVED, That within thirty (30) days of the agreement being fully
9 executed by all parties, the General Manager of the SFPUC shall provide the final agreement
10 to the Clerk of the Board for inclusion into the official file.


