3 **Resolution enacting and rescinding parking regulations at various locations.**

4 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
5 and the San Francisco Traffic Code, the following regulations governing the parking of
6 vehicles are hereby enacted or rescinded as designated below:

8 **TOW-AWAY NO PARKING (6AM - 6 PM 7AM - 5PM EXCEPT SATURDAYS, SUNDAYS
AND HOLIDAYS) - ESTABLISH**

9 California Street, north side, from 182 feet to 222 feet west of 32nd Avenue (40 foot
10 zone).

12 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - RESCIND**

13 California Street, north side, from 100 feet to 182 feet west of 32nd Avenue.
14

15 **ANGLE (45-DEGREE ANGLE) PARKING - ESTABLISH**

16 California Street, north side, from 100 feet to 182 feet west of 32nd Avenue (6 spaces).

18 **COMPACT ONLY PARKING - ESTABLISH**

19 California Street, north side, from 75 feet to 182 feet west of 32nd Avenue (7 spaces).

22 Categorically exempt from Environmental Review Class 1(c)(9)
23 changes in the traffic and parking regulations where such
24 changes do not establish a higher speed limit or result in more
25 than a negligible increase in the use of the street.

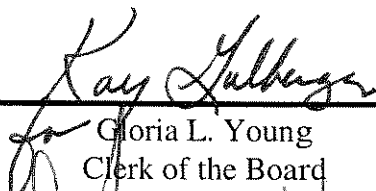

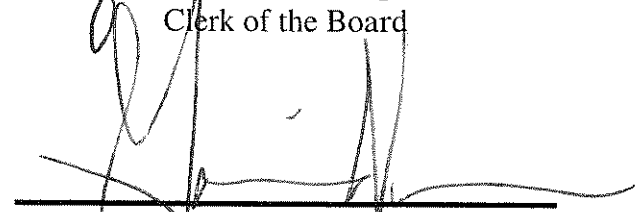
