San Francisco Immigrant Legal Education Network

- 1,167 unduplicated clients served
- 835 clients provided individual legal counseling and advice

San Francisco Immigrant Legal Defense Collaborative

- 933 unduplicated clients served
- 164 clients in first year of representation
- 147 clients in second year of representation
- 622 clients in third year of representation
