This is a twenty-one (21) year office lease with two five (5) year lease extension options. The lease gives the City the right but not the obligation to lease additional space in the building on the same terms and conditions so long as the option(s) is exercised by December 31, 2027. Further, the lease has a purchase option that gives the City the right but not the obligation to buy the property at the then fair market value, not to fall below \$200 psf, as determined by appraisal so long as the sale occurs no later than December 31, 2027. Amount of contract: initial base year rent \$0.00. First two years rent credit, starting the 3rd year, rent is \$41.20 psf escalating 3% annually. Commencing in May 2024. Lease- Hudson 1455 Market, LLC and City and County of San Francisco.
