2 AUTHORIZING THE SETTLEMENT OF THE LITIGATION BETWEEN THE CITY AND
3 COUNTY OF SAN FRANCISCO ("CITY") AND JOHN SHIMMICK CONSTRUCTION,
4 INC./OBAYASHI CORPORATION, JOINT VENTURE, AND FOUNDATION
5 CONSTRUCTORS, INC. (COLLECTIVELY REFERRED TO AS "SHIMMICK") IN THE
6 LAWSUITS CONSOLIDATED UNDER *IDEAL PAINT CO., INC. VS. CITY AND COUNTY OF*
7 *SAN FRANCISCO, AND CONSOLIDATED ACTIONS*, SAN FRANCISCO SUPERIOR

10 Section 1. The City Attorney is hereby authorized to settle the litigation entitled *Ideal*
11 *Paint Co., Inc. vs. City and County of San Francisco, and Consolidated Actions*, San
12 Francisco Superior Court Case No. 967-708 ("Actions") by payment to Shimmick in the
13 amount of \$209,000 from the City and \$51,000 from Dames & Moore, Inc. ("Dames &
14 Moore"). The City Attorney is further authorized to dismiss with prejudice the City's cross-
15 complaint against Shimmick in the Actions and to fully release Shimmick, its insurance
16 carriers, and Dames & Moore from all claims related to or arising from the Actions and/or the
17 public works project known as Contract "C", with the exception of claims for latent defects,
18 warranty claims, and/or claims for insurance coverage with respect to any future claims by
19 any third-party arising from the public works project known as Contract "C". As further
20 consideration for this settlement, Dames & Moore has agreed to fully release the City and
21 Shimmick from all claims for damages related to or arising from the Actions and/or the public
22 works project known as Contract "C", with the exception of claims against Shimmick and/or its
23 insurance carriers for insurance coverage with respect to any future claims by any third-party
24 arising from the public works project known as Contract "C". As consideration for this
25 settlement, Shimmick has agreed to dismiss with prejudice its cross-complaint against the

1 City in the Actions, and Shimmick and its carriers have agreed to fully release the City and
2 Dames & Moore from all claims arising from the Actions and/or the public works project
3 known as Contract "C".






