3 **Resolution designating certain intersections as "STOP" intersections.**

5 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the
6 following intersections are hereby designated as "STOP" intersections, and the
7 Department of Parking and Traffic is hereby authorized and directed to cause "STOP"
8 signs to be installed thereat as designated below:

9 **STOP SIGNS - ESTABLISH**

10 22nd Avenue and Moraga Street, stopping 22nd Avenue, making this intersection
11 an All-Way STOP;

12 Peru Avenue and Athens Street, stopping eastbound Peru Avenue, the stem of
13 this T-intersection;

14 Circular Avenue and Havelock Street, stopping southbound Circular Avenue
(legislates existing conditions);

15 Dorantes Avenue at Magellan Avenue, stopping Dorantes Avenue, making this
16 T-intersection an All-Way STOP; and,

17 Brighton Avenue at Lakeview Avenue, stopping southbound Brighton Avenue,
18 the stem of this T-intersection.

19 Categorically exempt from Environmental
20 Review Class 1(c)(9) changes in the traffic
21 and parking regulations where such
22 changes do not establish a higher speed
23 limit or result in more than a negligible
24 increase in the use of the street.


