3 GENERAL ALCOHOLIC BEVERAGE CONTROL LICENSE FROM 500 BEACH  
4 STREET, SPACE NOS. 117 AND 118 TO 2800 LEAVENWORTH STREET, SUITE 51  
5 TO RITCHARD F. ALMASSOU FOR BEACH LIQUORS WILL SERVE THE PUBLIC  
6 CONVENIENCE AND NECESSITY OF THE PEOPLE OF THE CITY AND COUNTY  
7 OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION 23958.4 OF THE  
8 CALIFORNIA BUSINESS AND PROFESSIONS CODE. WITH CONDITIONS.

10 WHEREAS, Ritchard F. Almassou is seeking transfer of a Type 21 off-sale  
11 general alcoholic beverage control license for Beach Liquors located at 2800  
12 Leavenworth Street, Suite 51; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
20 off-sale general alcoholic beverage control license from 500 Beach Street, Space Nos.  
21 117 and 118 to 2800 Leavenworth Street, Suite 51 for Ritchard F. Almassou for Beach  
22 Liquors, will serve the public convenience and necessity of the people of the City and  
23 County of San Francisco.

24 Conditions: 1.) Sales and service of alcoholic beverages shall be permitted only  
25 between the hours of 10:00 a.m. and 12 midnight. 2.) No wine shall be sold with an

1 alcoholic content greater than 15% by volume. 3.) No malt products shall be sold in  
2 less than six pack quantities per sale.




