4 **Resolution approving the First Amendment to the Refuse Collection Agreement**  
5 **between the City and County of San Francisco and Sunset Scavenger Company**  
6 **dba Recology Sunset Scavenger, Golden Gate Disposal & Recycling Company**  
7 **dba Recology Golden Gate, and Recology San Francisco, increasing the total not**  
8 **to exceed amount of the Agreement from \$40,000,000 to \$48,000,000 under**  
9 **Charter, Section 9.118(b), with no change to the term length to expire on**  
10 **November 30, 2020, to commence upon approval by the Board of Supervisors.**

12 WHEREAS, The Board of Supervisors approved Resolution No. 444-14 on  
13 November 25, 2014, waiving a competitive solicitation process and authorizing a refuse  
14 collection agreement for \$40,000,000 with Recology San Francisco, Recology Golden  
15 Gate, and Recology Sunset Scavenger for the term of December 1, 2014, through  
16 November 30, 2020; and

17 WHEREAS, This Agreement is approaching the contract amount of  
18 \$40,000,000; and

19 WHEREAS, The Charter, Section 9.118(b) provides that when agreements of  
20 \$10,000,000 or more are amended to increase the not to exceed amount by \$500,000  
21 or more, then such amendment shall be subject to approval of the Board of Supervisors  
22 by Resolution; and

23 WHEREAS, The Agreement and the proposed First Amendment are on file with  
24 the Clerk of the Board of Supervisors in File No. 190996, which are hereby declared to  
25 be part of this Resolution as if set forth fully herein; now, therefore, be it

1           RESOLVED, That the Board of Supervisors approves the First Amendment to  
2 the Contract with Recology San Francisco, Recology Golden Gate, and Recology  
3 Sunset Scavenger as described above; and, be it

4           FURTHER RESOLVED, That within 30 days of the contracts being fully  
5 executed by all parties, the Purchaser and Director of the Office of Contract  
6 Administration shall provide the final First Amendment to the Clerk of the Board for  
7 inclusion into the official file.
