

[Appointments, San Francisco Health Authority - Michael Chung and Tangerine Brigham]

Motion appointing Michael Chung (residency requirement waived), term ending January 15, 2029, and Tangerine Brigham (residency requirement waived), term ending January 15, 2027, to the San Francisco Health Authority.

MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated person(s) to serve as member(s) of the San Francisco Health Authority, pursuant to the provisions in the California Welfare and Institutions Code, Section 14087.36, and the San Francisco Administrative Code, Sections 69.1 et seq., for the terms specified:

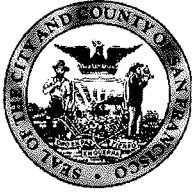
Michael Chung, seat 2, succeeding Jian Qing Zhang, resigned, must be employed in the senior management of a hospital not operated by the county or the University of California and who is a nominee of the San Francisco Section of Westbay Hospital Conference or any successor organization, or if no successor organization, a person who shall be nominated by the Hospital Council of Northern and Central California, for the unexpired portion of a three-year term ending January 15, 2029; and

Tangerine Brigham, seat 3, succeeding Roland Pickens, resigned, must be employed in the senior management of San Francisco General Hospital, for the unexpired portion of a three-year term ending January 15, 2027; and, be it

FURTHER MOVED, That the Board of Supervisors makes the following findings:

1. The membership of the San Francisco Health Authority has a goal to be representative of the diversity of the City and County of San Francisco.

- 1 2. Applicants Michael Chung and Tangerine Brigham, who are not residents of San
2 Francisco, are persons with experience that uniquely qualifies them to serve on the
3 San Francisco Health Authority.
- 4 3. The San Francisco Health Authority has attempted to fill the positions, for which
5 Michael Chung and Tangerine Brigham were nominated, with individuals who are City
6 residents and who have the specific experience, skills, and qualifications, but has been
7 unable to do so at this time. The Rules Committee has certified that Michael Chung
8 and Tangerine Brigham, are qualified to serve on the San Francisco Health Authority.
- 9 4. After exercising due diligence, the Board of Supervisors concludes that there are no
10 other possible representatives who are residents of San Francisco, who have the
11 specific experience, skills, or qualifications possessed by these applicants, and who
12 are willing to serve on the San Francisco Health Authority at this time; and, be it
13 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
14 for Michael Chung and Tangerine Brigham, as is allowed in cases where no qualified City
15 residents who are willing to serve can be found, pursuant to Charter, Section 4.101(b), that
16 otherwise requires person(s) appointed to boards, commissions, and advisory bodies
17 established by legislative act of the Board of Supervisors to be resident(s) of the City and
18 County of San Francis

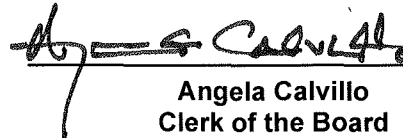
