3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) AIDS**  
4 **Office (AO) to accept and expend retroactively the second year of a grant in the amount**  
5 **of \$650,000 from the DHHS Office of Minority Health (DHHS OMH) to improve AIDS**  
6 **related health outcomes for women and minorities and to enter into an agreement for**  
7 **the use of these funds; for the period of September 30, 2002 to September 29, 2003.**

9 WHEREAS, SFDPH AO has applied for and been awarded a grant in the amount of  
10 \$650,000 from DHHS OMH to improve AIDS related health outcomes for women and  
11 minorities; and,

12 WHEREAS, As a condition of receiving the grant funds, DHHS OMH requires the City  
13 to enter into an agreement (the "Agreement"), a notice of which is on file with the Clerk of the  
14 Board of Supervisors in File No. 021984, which is hereby declared to be a part of this  
15 resolution as if set forth fully herein; and,

16 WHEREAS, The grant budget includes provision for indirect costs of \$12,133; now,  
17 therefore, be it

18 RESOLVED, That SFDPH AO is hereby authorized to accept and expend retroactively  
19 a grant in the amount of \$650,000 from DHHS OMH; and, be it


20 FURTHER RESOLVED, That SFDPH AO is hereby authorized to accept and expend  
21 the grant funds in accordance with the requirements set forth in the Agreement pursuant to  
22 the San Francisco Administrative Code section 10-170-1; and, be it


1 FURTHER RESOLVED, That the Controller is directed to designate the positions


