

1 [Accept and Expend Grant - Retroactive - California Department of Health Care Services -
2 DHCS Grant for San Francisco Chinese Hospital - \$1,000,000]

3 **Resolution retroactively authorizing the Department of Public Health to accept and**
4 **expend a grant in the amount of \$1,000,000 from the California Department of Health**
5 **Care Services for participation in a program entitled, “Department of Health Care**
6 **Services (DHCS) Grant for San Francisco Chinese Hospital,” to support the new**
7 **oncology clinic and chemotherapy center at the Chinese Hospital from July 1, 2025, to**
8 **December 31, 2026.**

10 WHEREAS, The California Senate passed the Senate Bill No. 105 on September 17,
11 2025; and

12 WHEREAS, The Senate Bill No. 105 has allocated \$1,000,000 to be provided as a
13 one-time payment to the City and County of San Francisco (City) to support the new oncology
14 clinic and chemotherapy center at the Chinese Hospital located in San Francisco, for 2025-
15 2026; and

16 WHEREAS, The California Department of Health Care Services (DHCS) has agreed to
17 fund the San Francisco Department of Public Health (DPH) in the amount of \$1,000,000 for
18 the period of July 1, 2025, through December 31, 2026; and

19 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

20 WHEREAS, A request for retroactive approval is being sought because DPH received
21 the award on January 20, 2026, for a project start date of July 1, 2025; and

22 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
23 therefore, be it

24 **RESOLVED**, That the Board of Supervisors hereby waives inclusion of indirect costs in
25 the grant budget; and, be it

1 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
2 expend a grant in the amount of \$1,000,000 from the DHCS; and, be it

3 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
4 expend the grant funds pursuant to Administrative Code, Section 10.170-1.

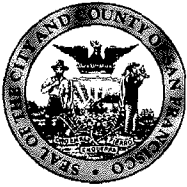
