3 **Resolution approving Amendment No. 1 to the agreement between Richmond Area**  
4 **Multi-Services, Inc. and the Department of Public Health for behavioral health services**  
5 **for adults, older adults, and Transitional Age Youth, to increase the agreement amount**  
6 **by \$13,472,596 for an amount not to exceed \$23,467,824; and to extend the term by**  
7 **three years, from June 30, 2020, for a total agreement term of July 1, 2018, through**  
8 **June 30, 2023.**

10 WHEREAS, The Department of Public Health selected Richmond Area Multi-Services,  
11 Inc. to provide behavioral health services as a result of multiple competitive solicitations  
12 conducted through 2017, for the period July 1, 2018, through June 30, 2020, for a total  
13 contract amount not to exceed \$9,995,228; and


14 WHEREAS, Under this contract, Richmond Area Multi-Services, Inc. provides  
15 behavioral health outpatient services, peer counseling, employment readiness, outreach and  
16 engagement, and residential services for adults, older adults and Transitional Age Youth,  
17 focusing on Asian and Pacific Islander (including Chinese, Filipino, Samoan, Cambodian,  
18 Laotian, and Vietnamese adults) and Russian-speaking communities; now, therefore, be it

19 RESOLVED, That the Board of Supervisors hereby authorizes the Director of  
20 Public Health and the Director of the Office of Contract Administration/Purchaser, on  
21 behalf of the City and County of San Francisco, to execute an agreement with  
22 Richmond Area Multi-Services, Inc. to increase the agreement amount by \$13,472,596  
23 for an amount not to exceed \$23,467,824; and to extend the term by three years, from  
24 June 30, 2020, for a total agreement term of July 1, 2018, through June 30, 2023; and,  
25 be it

1           FURTHER RESOLVED, That the Board of Supervisors authorizes the  
2 Department of Public Health to enter into any amendments or modifications to the  
3 contract, prior to its final execution by all parties, that the Department determines, in  
4 consultation with the City Attorney, are in the best interest of the City, do not otherwise  
5 materially increase the obligations or liabilities of the City, are necessary or advisable to  
6 effectuate the purposes of the contract, and are in compliance with all applicable laws;  
7 and, be it

8           FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed  
9 by all parties, the Director of Health and/or the Director of the Office of Contract  
10 Administration/Purchaser shall provide the final contracts to the Clerk of the Board for  
11 inclusion into the official File No. 200164.
