7 WHEREAS, Homelessness in many parts of America has reached crisis proportions;
8 and

9 WHEREAS, The results of the 2018 Department of Housing and Urban Development
10 ("HUD") point-in-time ("PIT") count found that 552,830 people are experiencing homelessness
11 in this country, including nearly 160,000 children and youth, and nearly 38,000 veterans; and

12 WHEREAS, The results of the 2018 Department of Homelessness and Supportive
13 Housing ("HSH") PIT count found 7,499 people are experiencing homelessness in this county;
14 and

15 WHEREAS, As the recipient of the second largest allocation of federal homeless
16 funding grants in the country, The City and County of San Francisco relies on federal funding
17 to address homelessness; and

18 WHEREAS, In Fiscal Year 2018, San Francisco received \$44,537,520 from HUD
19 through its Continuum of Care Competition; and

20 WHEREAS, The City and County of San Francisco's HSH current annual budget is
21 \$284.5 million, or approximately 5% of the city's total budget; and

22 WHEREAS, On March 25, 2019, Representative Maxine Waters [D-CA-43],

6 funding over the next five years to federal programs and initiatives to prevent and address
7 homelessness; and

8 WHEREAS, H.R. 1856 would appropriate \$5 billion over five years to McKinney-Vento
9 Homeless Assistance Grants, which is expected to provide 85,000 new permanent housing
10 units; and

11 WHEREAS, H.R. 1856 would appropriate \$2.5 billion over five years for new Special
12 Purpose Section 8 Housing Choice Vouchers (“HCV”), which are expected to provide an
13 additional 300,000 housing vouchers and would give preference to those who are homeless

15 WHEREAS, H.R. 1856 would appropriate \$1.05 billion annually in mandatory spending
16 dedicated to the National Housing Trust Fund, which in the first five years of funding is

20 funding to ensure that homeless people are connected to the resources they need; and

21 WHEREAS, H.R. 1856 would appropriate \$20 million for states and localities to provide

23 healthcare and housing initiatives that are funded by federal programs; and
