Resolution authorizing the Mayor's Office of Criminal Justice (MOCJ) to accept and expend a grant in the amount of \$99,833 from the State Corrections Standards Authority for the purposes of implementing local juvenile justice accountability measures through the Juvenile Accountability Block Grant (JABG).

WHEREAS, the Mayor's Office of Criminal Justice (MOCJ) desires to receive and utilize grant funds available through the Juvenile Accountability Block Grants (JABG) Program administered by the Corrections Standards Authority (hereafter referred to as CSA); and

WHEREAS, the grant does not require an ASO amendment;

NOW, THEREFORE, BE IT RESOLVED, that the Director of MOCJ is authorized, on behalf of the City and County of San Francisco Board of Supervisors to submit the JABG application to CSA and is authorized to sign the Grant Agreement with the SCA, including any amendments thereof.

BE IT FURTHER RESOLVED that the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget.

BE IT FURTHER RESOLVED that the City and County of San Francisco agrees to provide all matching funds required for said project (including any amendment thereof), and abide by the statutes and regulations governing the JABG Program as well as the terms and conditions of the Grant Agreement as set forth by the CSA.

BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
