14	Section 1. Findings				
15	A.	The Depart	ment of Administrative Services provides Publishing and Mail		
16	Services to the departments of the City and County of San Francisco. "Publishing and Mail				
17	Services" means publishing, copying, printing and/or mail services.				
18	B.	The Depart	ment of Administrative Services is able to provide Publishing and		
19	Mail Services to other public entities at rates that are lower than the rates such agencies				
20	would otherwise pay for such services.				
	C.	By providin	g such Publishing and Mail Services to other public entities, the		
21	Department of Administrative Services would increase the revenues of the City and County of				
22	San Francisco, enable the City and County to benefit from economies of scale including				
23	reductions in the per unit costs of the services, and benefit the residents of the City and				
24	County by lowering the cost of such services to public agencies serving the City and County,

1	such as the San Francisco Unified School District, and foster good relations with our			
2	neighboring public agencies and promotes a healthy reciprocity with the agencies.			
3	D. For the aforementioned reasons, authorizing the Department of Administrative

6	San Francisco and, therefore, is a public use of the City and County resources that benefits al			
7	the residents of the City and County.			
8	Section 2. The Board of Supervisors hereby authorizes the Director of the Department			
9	of Administrative Services or his or her designee to enter into written agreements with other			
10	public entities for Publishing and Mail Services at rates that are lower than what the public			
11	agencies would otherwise pay for such services, and ratifies and approves any and all actions			
12	heretofore taken by the Department of Administrative Services to provides such services to			
13	public entities.
