3 **Resolution authorizing the Chief of Police for the City and County of San Francisco to**
4 **accept and expend a gift in the amount of \$40,000.00 from the *Supporters of the San***
5 ***Francisco Police Department's Wilderness Adventure Youth Program*, a non-profit**
6 **organization [501 (c) (3)], for the purchase of two new passenger vans to use on Youth**
7 **Wilderness Trips.**

9 WHEREAS, The Chief of Police of the City and County of San Francisco desires to
10 accept gift funds for the purchase of two new passenger vans; and

11 WHEREAS, The purchase of these two new vehicles will provide the ability to continue
12 to safely and effectively transport students involved in the Police Department's Wilderness
13 Program; and,

14 WHEREAS, The Chief of Police for the City and County of San Francisco is authorized
15 on behalf of the City and County of San Francisco to accept these funds and purchase these
16 two new passenger vans through the City and County of San Francisco's Fleet program; and

17 WHEREAS, This program requires no matching funds; and

18 WHEREAS, This program requires that the costs of ownership and maintenance over
19 the life of the vehicles be incurred by the Police Department; and

20 WHEREAS, The execution of the gift does not require an ASO amendment; now,
21 therefore, be it

22 RESOLVED, That the Chief of Police for the City and County of San Francisco is
23 authorized to execute on behalf of the City and County of San Francisco this gift; and, be it

1 FURTHER RESOLVED, that the San Francisco Police Department, at its own
2 expense, agrees to the costs of ownership and maintenance over the life of the vehicles; and
3 be it


4 FURTHER RESOLVED, that it is agreed that any liability arising out of the performance


