1	[Continuum of Care Plan—Homeless Board Membership.]
2	
3	Resolution amending the Continuum of Care Plan to dissolve the current Local
4	Homeless Coordinating Board and to restructure it to reflect the recently adopted Ten
5	Year Plan to End Chronic Homelessness reducing its membership to nine: four
6	appointed by the Mayor; four appointed by the Board of Supervisors; and one
7	appointed by the Controller.
8	
9	WHEREAS, The Board of Supervisors adopted the Continuum of Care Plan as San
10	Francisco's homeless policy document governing the development of an integrated, effective
11	and coordinated system of health care, housing, employment and support services to prevent
12	and reduce homelessness, by Resolution No. 827-97; and
13	WHEREAS, A component of the Continuum of Care Plan was the creation of a Local
14	Homeless Coordinating Board (Local Board) to advise City departments, commissions, and
15	the Board of Supervisors on policy decisions and budget allocations consistent with the Plan;
16	and
17	WHEREAS, Since its inception, the Local Board has struggled to fulfill its charge,
18	maintain a quorum, and be viewed as the homeless policy making body for San Francisco,
19	often being overlooked by policy makers when homeless policy was debated; and
20	WHEREAS, In May 2002, both the Controller and the Civil Grand Jury published
21	reports criticizing the way homeless policy is formulated in San Francisco and recommending
22	dramatic changes to the structure, size and membership of the Local Homeless Coordinating
23	Board; and
24	WHEREAS, Local, State and federal homeless policy priorities and direction has
25	changed since the completion of the first Continuum of Care Plan in 1996; and

1	WHEREAS, Beginning in late 2003, the newly formed Presidential Interagency Council
2	on Homelessness shifted the National homeless policy debate from "managing
3	homelessness" to "ending chronic homelessness"; and
4	WHEREAS, The Mayor of the City and County of San Francisco established a planning
5	group in the Spring of 2004 entitled, "The Ten Year Plan to End Chronic Homelessness
6	Council"; and
7	WHEREAS, The Council published a report in July 2004 with a series of
8	recommendations aimed at ending chronic homelessness by 2014; and
9	WHEREAS, The Continuum of Care Plan is no longer San Francisco's only homeless
10	policy document governing the development of an integrated, effective and coordinated
11	system of health care, housing, employment and support services to prevent and reduce
12	homelessness; and
13	WHEREAS, Successful implementation of the Ten Year Plan will require integration
14	and coordination with the Continuum of Care Plan; and
15	WHEREAS, The current Local Board was a direct outgrowth of the original Continuum
16	of Care Plan and does not reflect current trends in homeless policy; and
17	WHEREAS, The Local Board held a retreat in November 2004 with the goal of
18	restructuring the Board to be a more effective body responsive to the needs of San
19	Franciscan's and incorporating the direction of the Ten Year Plan to End Chronic
20	Homelessness; and
21	WHEREAS, Following the retreat, the Local Board formed an Ad Hoc committee to
22	develop a proposal to present to the Board of Supervisors by December 31, 2004 for
23	reconstituting itself; and
24	WHEREAS, After exploring best practices by other Local Boards, consulting with
25	experts in the field and reviewing the Controller's and Civil Grand Jury reports, the consensus

1	proposal developed by the Ad Hoc committee and unanimously approved by the Local Board
2	January 10, 2005 would dissolve the Local Board and reconstitute its membership; and
3	WHEREAS, The current members of the Local Board believe that this proposal
4	represents the best opportunity for a revitalized and viable Local Homeless Coordinating
5	Board in keeping with the City's goal to end homelessness; and
6	WHEREAS, This consensus document includes planning assumptions, vision and
7	mission, goals, the size of the Local Board, appointment process, functions, committee
8	structure and required staffing levels; now, therefore, be it
9	RESOLVED, That the Board of Supervisors amends the Continuum of Care Plan to
10	incorporate the recommendations of the above proposal and hereby disbands, effective
11	August 1, 2005, the current Local Board and reconstitutes, effective August 1, 2005, the Local
12	Board to nine members; and, be it
13	FURTHER RESOLVED, That the Board of Supervisors will appoint one member from
14	the disabled community and three members from one of the following constituencies:
15	representatives of homeless, formerly homeless, community and advocacy organizations,
16	service-provider agencies, business and corporate sectors and the foundation community, but
17	will not involve designating specific seats for specific constituencies; and be it
18	FURTHER RESOLVED, That the Mayor shall appoint one member from the disabled
19	community and three members from one of the following constituencies: representatives of
20	homeless, formerly homeless, community and advocacy organizations, service-provider
21	agencies, business and corporate sectors and the foundation community, but will not involve
22	designating specific seats for specific constituencies; and be it
23	FURTHER RESOLVED, That the Controller shall appoint one member from one of the
24	aforementioned categories; and, be it

1	FURTHER RESOLVED, That staff from the Department of Human Services, the
2	Department of Public Health, the Mayor's Office of Housing, the Mayor's Office of Community
3	Development and the Mayor's Office of Disability will support Local Board efforts, will provide
4	relevant information and act as a resource for the Local Board; and, be it
5	FURTHER RESOLVED, The Local Board shall, on a semi-annual basis, provide a
6	written report to the Board of Supervisors consisting of the following information: updates on
7	the implementation of the Continuum of Care Plan and the Ten Year Plan, the status of the
8	integration and coordination of the Ten Year Plan with the Continuum of Care Plan, the status
9	of McKinney funding, a report from the Shelter Monitoring Committee and any other policy
10	issues of which the Local Board wishes to inform the Board of Supervisors; and, be it
11	FURTHER RESOLVED, it is the policy of the Board of Supervisors that funding for an
12	Executive Director to the Local Board should be included in this year's budget and the Board
13	of Supervisors urges the Mayor to include funding for an Executive Director position in the
14	2005-2006 budget and further urges the Mayor to determine whether any additional staff are
15	necessary for the Local Board and, if so, to also include in budget the appropriate level of
16	funding for those potions; and, be it
17	FURTHER RESOLVED, Members of the Local Board shall serve four year terms at the
18	pleasure of their appointing officer. To stagger the terms, four members shall serve an initial
19	term of two years and five members shall serve an initial term of five years. The terms shall
20	be determined by the Clerk of the Board of Supervisors by the drawing of lots.
