3 **Resolution authorizing the Department of Public Works to accept and expend a federal**
4 **grant in the amount of \$482,040 from the California Department of Transportation to**
5 **upgrade guardrails at Twin Peaks Boulevard; O'Shaughnessy Boulevard at Del Valle**
6 **Avenue; Portola Drive north of Burnett Avenue and west of Burnett Avenue.**

8 WHEREAS, The San Francisco Department of Public Works (DPW) is eligible to
9 receive federal funding for certain transportation projects through the California Department of
10 Transportation (Caltrans); and,

11 WHEREAS, The Highway Safety Improvement Program (HSIP) provides federal funds
12 for safety improvements on any public road, any public surface transportation facility, or any
13 publicly-owned bicycle or pedestrian pathway or trail, and for any traffic calming measure;
14 and,

15 WHEREAS, DPW submitted applications for safety improvement projects for the Fiscal
16 Year 2006-2007 HSIP cycle; and,

17 WHEREAS, DPW was awarded a \$482,040 HSIP grant to upgrade guardrails at Twin
18 Peaks Boulevard; O'Shaughnessy Boulevard at Del Valle Avenue; Portola Drive north of
19 Burnett Avenue and west of Burnett Avenue; and,

20 WHEREAS, The grant budget includes provision for indirect costs of approximately
21 \$51,820; and,

22 WHEREAS, The grant does not require an ASO amendment; now, therefore, be it

23 **RESOLVED**, That the San Francisco Board of Supervisors authorizes DPW to accept
24 and expend \$482,040 in federal funds from Caltrans to upgrade guardrails at Twin Peaks


