12 procedures within each system and across systems to better achieve safety and prevent
13 further abuse for battered women and their children; and,

14 WHEREAS, The Department of Human Services desires to develop and implement
15 training and staff development within each system and across systems; and,

16 WHEREAS, The Department of Human Services desires to hire consultants to develop
17 and implement this program; and

18 WHEREAS, The U.S. Department of Health and Human Services, Administration on
19 Children, Youth and Families will grant ~~\$349,380~~ ^{\$1,048,140} for this program; and,

20 WHEREAS, The Department proposes to maximize use of available grant funds on
21 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

22 **RESOLVED**, That the Board of Supervisors hereby waives inclusion of indirect costs in
23 the grant budget; and be it
