[Grant of Federal Funds.]

Resolution authorizing the Municipal Transportation Agency to accept and expend a grant of \$90,000 in federal funds from the Metropolitan Transportation Commission to model and retime traffic signals along Market Street and King St./The Embarcadero.

WHEREAS, The Metropolitan Transportation Commission ("MTC") has determined that proactively retiming traffic signals every three to five years would benefit the Bay Area through improved mobility, safety, and air quality; and,

WHEREAS, MTC has created the Regional Signal Timing Program ("RSTP") to obtain those benefits with federal funding from the Federal Highway Administration of the U.S. Department of Transportation; and,

WHEREAS, In December 2005, the MTC invited Bay Area cities to apply for grants to retime traffic signals within their jurisdictions; and,

WHEREAS, The Municipal Transportation Agency applied for, and was awarded, an RSTP grant in the amount of \$90,000 to retime and provide transit or light rail priority for 33 signalized intersections along Market Street between Castro Street and Spear Street, and 27 signalized intersections along King Street between The Embarcadero and North Point and The Embarcadero between 5th Street and King Street ("the Project"); and,

WHEREAS, Under the grant, MTC will also provide consultant services to the MTA Planning Division to help in modeling and retiming the subject traffic signals, which consultant will indemnify, defend, and hold harmless the City/MTA should any of its activities result in injuries or claims; and

WHEREAS, On April 18, 2006, the MTA Board of Directors adopted Resolution No. 06-038, which authorized the acceptance and expenditure of a grant in the amount of \$90,000






