

1 [Affirming the CEQA exemption determination issued for proposed ordinance regulating off-  
2 street parking in C-3 zoning districts.]

3 **Motion affirming the determination by the Planning Department that a proposed**  
4 **ordinance regulating off-street parking in C-3 zoning districts is exempt from**  
5 **environmental review under the California Environmental Quality Act.**

7 WHEREAS, The Environmental Review Office of the San Francisco Planning  
8 Department issued a determination of exemption/exclusion from environmental review for an  
9 ordinance regulating off-street parking in C-3 zoning districts on September 23, 2005 (the  
10 "determination). A copy of said document is on file with the Clerk of the Board of Supervisors  
11 in File No. 051996, and is incorporated by reference herein; and,

13 WHEREAS, By letter to the Clerk of the Board of Supervisors dated December 5, 2005,  
14 Wade Randlett on behalf of SFSOS filed an appeal of the determination to the Board of  
15 Supervisors, which the Clerk of the Board of Supervisors received on or around December 5,  
16 2005; and,

18 WHEREAS, On January 10, 2006, this Board held a duly noticed public hearing to  
19 consider the appeal of the determination; and,

20  
21 WHEREAS, This Board has reviewed and considered the determination, the appeal  
22 letter, the responses to concerns document that the Planning Department prepared, and  
23 public testimony; and,

25 WHEREAS, The determination files and all correspondence and other documents have  
26 been made available for review by this Board and the public. These files are available for  
27 public review by appointment at the Planning Department offices at 1660 Mission Street, and  
28 are part of the record before this Board by reference herein; now, therefore, be it
