2 Assistance to Firefighters Grant Program - Personal Protection Equipment - \$2,325,133.81]

3 **Resolution retroactively authorizing the Fire Department to accept and expend a grant**
4 **in the amount of \$2,325,133.81 from the Federal Emergency Management Agency**
5 **(FEMA) Assistance to Firefighters Grant Program to purchase Personal Protection**
6 **Equipment (PPE) for the performance period of September 12, 2023, through**
7 **September 11, 2025.**

9 WHEREAS, The Fire Department (SFFD) responds to over 150,000 incidents each
10 year, including fires, vehicle accidents, and medical and other emergencies; and

11 WHEREAS, Due to San Francisco's geographic and topographic layout, as well as
12 other factors, the SFFD is confronted with unique challenges in responding to these incidents;
13 and

14 WHEREAS, The SFFD applied for and was awarded a Fiscal Year 2022 Assistance to
15 Firefighters Grant (AFG) from FEMA in the amount of \$2,325,133.81 for new Turnout PPE
16 Coats and Pants designed to protect firefighters from serious injuries or illness resulting from
17 contact with fire, Chemical, Biological, Radiological, Nuclear, and Explosives (CBRNE)
18 hazards and more; and

19 WHEREAS, The use of these grant funds will allow the SFFD to procure new compliant
20 PPE equipment to replace existing Turnout PPE Coats and Pants designed to protect
21 firefighters from serious injuries or illness resulting from contact with fire and CBRNE, and
22 thereby strengthening the SFFD's ability to ensure the safety and health of its members; and

23 WHEREAS, The FEMA grant requires SFFD to purchase the equipment by
24 September 11, 2025; and

1 WHEREAS, The Fire Commission recommended approval of this grant at its meeting
2 on October 11, 2023; and

3 WHEREAS, The grant does not require an ASO amendment; and

4 WHEREAS, The grant requires the City to supply matching funds worth 10 percent of
5 the total award, or \$232,513.39; and

6 WHEREAS, The SFFD will provide matching funds worth 10 percent of the total award,
7 or \$232,513.39; and

8 WHEREAS, The SFFD proposes to maximize the use of the grant funds on program
9 expenditures by not including indirect costs in the grant budget; now, therefore, be it

10 RESOLVED, That the Board of Supervisors authorizes the SFFD to accept and expend
11 grant funds in the amount of \$2,325,133.81 from FEMA for the purpose of purchasing new
12 personal protective equipment; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
14 indirect costs in the grant budget; and, be it

15 FURTHER RESOLVED, That the Chief of the SFFD is hereby authorized and
16 empowered to execute, deliver, and perform, in the name of the City and County of San
17 Francisco, all applications, contracts, agreements, amendments, and payment requests
18 necessary for the purpose to secure the FEMA grant funds and implement and carry out the
19 purposes specified in the applicable grant application; and, be it

20 FURTHER RESOLVED, That within thirty (30) days of the agreement being fully
21 executed by all parties, SFFD shall provide the final grant agreement to the Clerk of the Board
22 for inclusion into the official file.

The City and County of San Francisco (CCSF) and the San Francisco Fire Department (SFFD) protects collectively almost 500 National, State and City Designated Historical Landmarks and over a thousand critical infrastructure to include but not limited to major sports arenas, regional postal facilities, reservoirs, water treatment facilities, under bay fuel transmission lines, power and energy grids, educational (129 schools, 27 colleges/universities) and, medical (14 hospitals) facilities, research, and financial institutions including a Federal Reserve Bank. The City owns and operates several vital facilities (airport, hospital, recreation, police and fire facilities), critical infrastructure and delivery systems (water and power stations), located outside county limits. San Francisco, a natural peninsula surrounded by water on three sides, has two major bridges, the San Francisco-Oakland Bay Bridge and the Golden Gate Bridge. While the current pandemic has reduced traffic and commuter volume, the city has returned to historical daily commuter rates of roughly 456,000 vehicles and local, Bay Area Region and State-wide public transportation ridership is resuming, both contributing to the cities traditional daily population numbers of over one and a half million people on any given day. Additionally, the Port of San Francisco, oversees a cruise ship terminal, which has resumed operations post pandemic and hosts over 80 cruise ship calls and 300,000 passengers annually. The City's 47.355 square mileage is geographically circuitous and includes the Golden Gate National Recreation Area, Treasure/Yerba Buena Island, parts of Angel Island and the San Francisco International Airport. Meanwhile, San Francisco's infrastructure is distinctively susceptible to fire with approximately 48,000 Victorian houses built before 1915 primarily constructed of wood, 380,971 housing units, and a growing downtown with 72 high-rises and 26 skyscrapers. Additionally, the City's location makes it subject to the effects of weather and seismic related incidents such as earthquakes, tsunamis, strong sea winds, annual storms that combined with years of consistent drought and the increased heating effects of climate change have, contributed to recent power outages, road and bridge hazards, and urban and wildland fires. San Francisco is one of the top seven Tier1 Urban Area Ranking cities by the U.S. Department of Homeland Security, meaning if any critical infrastructure were damaged or destroyed within the San Francisco city limits, it would inflict catastrophic consequences on the city and regional populations. The SFFD collaborates with multiple partners and the

neighboring counties to receive and provide mutual aid response to mitigate the destructive effects of natural disasters, urban conflagration, and human-caused hazards.

Describe your financial need and how consistent it is with the intent of the AFG Program. The COVID pandemic has made an already challenging fiscal environment for the SFFD's budget ripe for further deterioration. Financial losses associated with the COVID pandemic have been stark and immediate across the City, and the level of uncertainty in acquiring adequate business and other city and county tax revenues to meet rising expenditures is historically high. The City and County of San Francisco has been forced to rely on Federal relief funds to maintain many day-to-day operations to include essential equipment, supplies and training. Financial recovery from the pandemic over the last three years has been slow and bumpy, and is expected to be a long and arduous process over the next five to ten years. Over the next two fiscal years, the City is projecting a \$728 million budget deficit, and as a result, the Mayor has requested a 5% reduction of city department/agency reliance on city general funds (city and county tax and revenue generated funds) to address the current fiscal year deficit. Given these fiscal realities, the SFFD is not anticipating being able to fund the replacement of critical Personal Protection Equipment (PPE) without supplemental funding. As the City continues to grapple with increased challenges of the COVID response and other fiscally taxing events, funding for these expenditures is increasingly harder to come by at a time when they are needed most given the dangers of the COVID virus, the state's drought status and susceptibility to wildfires and climate change driven natural disaster. With these constraints, these non-salary initiatives will be nearly impossible to implement using general fund allocations. Furthermore, the SFFD

has worked within the last three years to decrease its reliance on city and county general funds and increase grant funding to support the acquisition of required, mandated, and needed equipment, training and supplies, though the implementation of a strategic grant and budget committee. This committee includes oversight from our Diversity Inclusion and Equity Office and our Hazard Mitigation Committee to identify the SFFD's priority needs, strategic projects, aligned grant funding opportunities, ensuring that the SFFD seeks funding to meet priority needs while also meeting DEI and climate change mandates, initiatives, and policies. While we are making some gradual process in our attempts to increase revenue streams, the needs of the SFFD remain urgent and underfunded, therefore the SFFD requests funding from the FEMA AFG program to protect our members and community now and in the near future.

The Department has faced an annual increase in total call volume over the past decade with a noted overall 10% increase in incidents over the last three years to include medical emergency, traffic accident, substance overdose, mental health crisis, and violent incident related calls. Additionally, call volume over the last three years has increased dramatically in specific categories such as Rescue & Emergency Medical Service Incidents, Hazardous Conditions (no fire), Severe Weather and Natural Disaster, NFIRS Series 100 Structure Fires, Motor Vehicle Accidents and NFIRS Series 300 Extrications from Vehicle calls. In 2022, the department's Community Paramedicine Response Teams responded to 7,898 calls for rescue and emergency medical services. These teams routinely respond to the needs of the cities most vulnerable and underserved communities to include but not limited to those experiencing homelessness, mental health crisis, health disparities associated with substance use, abuse and overdose. The San Francisco Fire Department (SFFD) expects to see a continued increase in San Francisco based call volume and regional mutual aid assistance requests in review of internal call volume data analysis and external expert science-health based studies over the last 10 years. This analysis clearly predicts a near future in which SFFD first responders must be ready and equipt to respond to the magnitude of calls from those experiencing continued communicable disease outbreaks, surges in health disparities particularly in low-income, elderly and racially marginalized communities, increases in mental health distress and substance abuse across all socio-economic communities, climate changes affects on the magnitude, frequency and range of wildfires, flooding and extreme weather patterns, natural and anthropogenic hazards affects on vital resources (water, air and soil pollution/contamination) and food, equipment and supply chain disruptions.

The City and County of San Francisco is ranked as one of the top 100 most densely populated major cities and 58th largest populated county in the United States, with the US Census reporting a total estimated residential county population of 881,549, increasing dramatically on any given day, with the influx of commuters and tourists, despite current pandemic stay at home mandates. According to the most recently reported US Census Bureau estimates, San Francisco County's population's racial demographic makeup was 46.4% White, 34.4% Asian, 7.7% Unknown Race, 5.2% Black/African American, 5.6% from two or more races, 0.4% Native Hawaiian-Pacific Islander, 0.4% Native American/Alaskan Native. Additionally, census data further illustrates the cultural and ethnic diversity within the city with 15.2% of the population identify as Latinx (regardless of race) and an estimated 163 languages spoken at home by residents. Meanwhile, the city's 47.355 square mileage is geographically circuitous, and the city's topography is difficult to maneuver with old and narrow streets and over 50 hills from 100 to 927 feet within its city limits. San Francisco's infrastructure is distinctively susceptible to fire with approximately 380,971 housing units, 48,000 historic wood houses, and a growing downtown with 72 high-rises and 26 skyscrapers. Recently, the State of California has certified the city and county of San Francisco's new housing plan, which calls for the creation of over 82,000 homes – more than tripling the city's decades long, annual housing production

average. Recognizing the City's current, unique and forthcoming fire suppression and emergency medical service needs, the SFFD has in its ranks approximately 1,165 Firefighting and Emergency Medical Personnel and a fleet of 44 Engines, 20 Trucks, 40 ambulances, divided into two Divisions, with ten Battalion Districts and 44 stations located throughout the city, and fortified with specialty units including: 2 Heavy Rescue Squads, 2 Coastal Rescue units (Cliff & Surf), 1 Rescue Boat, 2 Rescue Water Craft, 3 Fireboats, a Mobile Command Vehicle, 2 Multi-Casualty Units, a Hazardous Materials Unit, a CO2 unit, and a Mobile Air Unit. The SFFD responded to 303,293 calls for service last year, and provided the public with; 1) emergency medical services, fire suppression, and specialized unit deployment in times of emergency, 2) Fire prevention code enforcement, investigation and inspection programs minimizing loss of life and property, 3) emergency planning and community disaster response coordination, to ensure the protection of thousands of lives should a large-scale disaster occur, and 4) community outreach to promote community health and fire safety. In the last three years, the SFFD and its community of residents, citizens and visitors faced the unprecedented challenges of the COVID pandemic health crisis, regional wildfires, multiple 4 and 5 alarm infrastructure fires and the fatality of a member in the line of duty. Despite these challenges and their test to the fortitude of various city infrastructure and the departments aging equipment, the men and women who serve through the SFFD are unfailingly ready to respond to any type of crisis at any time. Chief Jeanine Nicholson, the 26th Fire Chief of San Francisco continues to strategically lead a strong team focused on strengthening the SFFD's service model while increasing the Departments fiscal capacity to acquire and utilize the critical tools needed to effectively protect the property and lives of its members and the people of San Francisco and surrounding communities.

Article 1**Assurances, Administrative Requirements, Cost Principles, Representations and Certifications**

I. The Buy America preference only applies to articles, materials, and supplies that are consumed in, incorporated into, or affixed to an infrastructure project. As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does a Buy America preference apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project but are not an integral part of the structure or permanently affixed to the infrastructure project. Waivers When necessary, recipients may apply for, and the agency may grant, a waiver from these requirements. Information on the process for requesting a waiver from these requirements is on the website below. (a) When the federal agency has made a determination that one of the following exceptions applies, the awarding official may waive the application of the domestic content procurement preference in any case in which the agency determines that: (1) applying the domestic content procurement preference would be inconsistent with the public interest; (2) the types of iron, steel, manufactured products, or construction materials are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or (3) the inclusion of iron, steel, manufactured products, or construction materials produced in the United States will increase the cost of the overall project by more than 25 percent. RESOLUTION RECOMMENDING THAT THE BOARD OF SUPERVISORS AUTHORIZE THE SAN FRANCISCO FIRE DEPARTMENT TO ACCEPT AND EXPEND ASSISTANCE TO FIREFIGHTERS GRANT (AFG) PROGRAM FUNDING IN THE AMOUNT OF \$2,325,133.81 FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) TO PURCHASE PERSONAL PROTECTION EQUIPMENT (PPE)

WHEREAS, The San Francisco Fire Department (SFFD) responds to over 150,000 incidents each year, including fires, vehicle accidents, and medical and other emergencies; and,

WHEREAS, Due to San Francisco's geographic and topographic layout, as well as other factors, the SFFD is confronted with unique challenges in responding to these incidents; and

WHEREAS, The SFFD applied for and was awarded a Fiscal Year 2022 Assistance to Firefighters Grant (AFG) from the Federal Emergency Management Agency (FEMA) in the amount of \$2,325,133.81 for Personal Protection Equipment; and,

WHEREAS, The use of these grant funds will allow the Department to procure new compliant Personal Protection Equipment of Turnout Coats and Pants designed to protect firefighters from serious injuries or illness resulting from contact with fire, as well as Chemical, Biological, Radiological, Nuclear, and Explosives (CBRNE) hazards and more; and

WHEREAS, The grant requires the City to supply matching funds worth 10 percent of the total award, or \$232,513.39; and,

WHEREAS, The SFFD wishes to accept and expend the grant, to support and promote strengthening the Department's ability to ensure the safety and health of its members; now, therefore, be it

RESOLVED, That the Fire Commission recommends that the Board of Supervisors authorize the Fire Department to accept and expend AFG funding from FEMA in the amount of \$2,325,133.81 to purchase

Personal Protection Equipment to support the Department's fire suppression response capabilities and increase member safety and the protection of members' health.

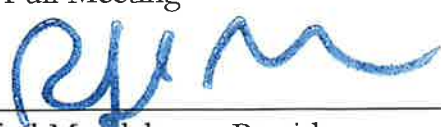
