APPROVE ASSEMBLY BILL 421 RELATING TO THE DOWNGRADE OR CLOSURE OF

URBAN HOSPITAL EMERGENCY DEPARTMENTS.

WHEREAS, Existing law provides that a health facility with a license or special permit to provide emergency services may surrender its license or special permit with the approval of the State Department of Health Services; and,

WHEREAS, Existing law places specified restrictions, including departmental review of the county impact evaluation, on approval of the downgrade or closure of emergency services; and,

WHEREAS, The California State Legislature is currently considering Assembly Bill 421 which was introduced by Assembly Member Aroner; and,

WHEREAS, Assembly Bill 421 would prohibit the California Department of Health Services from approving the downgrade or closure of an urban hospital emergency department if a county or its designated emergency services agency concludes that it would not be in the best interest of the general public; and,

WHEREAS, Assembly Bill 421 would allow a hospital to appeal a determination that a downgrade or closure is not in the best interest of the general public to the Secretary of the California Health and Human Services Agency; and,

WHEREAS, Assembly Bill 421 is on file with the Clerk of the Board of Supervisors in File No. 991039; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco endorses Assembly Bill 421 and urges the Legislature and Governor to approve this legislation; and, be it

FURTHER RESOLVED, That a copy of this resolution be forwarded to his Honor, the Mayor, with a request that he transmit copies to the delegation from San Francisco in the State Legislature, as well as Governor Davis, with a request they take all action necessary to achieve the objectives of this resolution.
