2 URGING THE SUPERIOR COURT IN COOPERATION WITH MUNI AND THE
3 TRANSPORTATION AUTHORITY TO CREATE A PUBLIC INFORMATION DEMONSTRATION
4 PROJECT TO PROVIDE PUBLIC TRANSIT INFORMATION TO INDIVIDUALS SERVING
5 JURY DUTY.

7 WHEREAS, Reducing excessive vehicular traffic congestion and
8 parking problems in the City should be encouraged whenever possible;
9 and,

10 WHEREAS, Providing information related to public transportation
11 to and from the City's two court locations to individuals serving on
12 jury duty is in the City's interest and in accordance with the City's
13 transit first policy; and,

14 WHEREAS, Parking in the South of Market area and near the Hall
15 of Justice is particularly difficult and costly to City residents
16 performing their civic duty; and,

17 WHEREAS, Data for day time traffic suggests increased use of
18 public transit to and around the Hall of Justice is an achievable
19 goal; and,

20 WHEREAS, Muni and the Transportation Authority have the means to
21 tailor information to encourage the use of public transit by City
22 residents serving jury duty; now, therefore, be it

23 RESOLVED, That the Board of Supervisors urges the Superior Court
24 in cooperation with Muni and the Transportation Authority to create a

1 public information demonstration project to provide public transit
2 information to individuals serving jury duty; and, be it

3 FURTHER RESOLVED, That such a project be designed to increase
4 ridership on public transit, particularly to the Hall of Justice;
5 and, be it

6 FURTHER RESOLVED, That a copy of this resolution be transmitted
7 to the Superior Court, Muni and the Transportation Authority.




