

1 [Adopting findings related to the tentative parcel map appeal on property located at 554  
2 Valley].

3 **Motion adopting findings related to the appeal of the decision of the Department of**  
4 **Public Works approving tentative parcel map for a 2-lot subdivision project located at**  
5 **554 Valley Street (Lot 081 in Assessor's Block 6611).**

7 The appellant, Betty Jean Wilkinson, filed a timely appeal on October 28, 2005  
8 protesting the approval by the Department of Public Works of a tentative parcel map for a 2-lot  
9 subdivision project located at 554 Valley Street, Lot 081 in Assessor's Block 661. The public  
10 hearing before the Board of Supervisors on said appeal was held on November 22, 2005.

11 Following the conclusion of the public hearing on November 22, 2005, the Board  
12 approved the decision of the Department of Public Works, and approved the tentative parcel  
13 map for a 2-lot subdivision project located at 554 Valley Street, Lot 081 in Assessor's Block  
14 661, subject to all of the conditions imposed by the reviewing City Departments.

15 In reviewing the appeal of the approval of the tentative map this Board reviewed and  
16 considered the written record before the Board.

17 NOW, THEREFORE, BE IT MOVED, That the Board of Supervisors of the City and  
18 County of San Francisco hereby adopts as its own and incorporates by reference herein, as  
19 though fully set forth, the findings made by the Department of Public Works, the Department  
20 of City Planning, and the Department of Building Inspection in their review and approval of the  
21 proposed tentative map. In particular, the Board finds that the tentative map complies with  
22 applicable provisions of the Planning Code. In addition, on balance, the tentative map is  
23 consistent with the General Plan and the priority Policies of Planning Code Section 101.1,  
24 based on the findings made in the record. The Board further notes that the proposed project  
25 received environmental review by the Planning Department, and that the Board further finds

1 that there have been no substantial project changes, no substantial changes in project  
2 circumstances, and no new information of substantial importance that would change the  
3 conclusions reached in the environmental review.

4 FURTHER MOVED, That the Board of Supervisors, after carefully balancing the  
5 competing public and private interests, approved the decision of the Department of Public  
6 Works and approved the tentative parcel map for a 2-lot subdivision project located at 554  
7 Valley Street, Lot 081 in Assessor's Block 661, subject to all of the conditions imposed by the  
8 reviewing City Departments.


