8 WHEREAS, The San Francisco Police Department (SFPD) applied for funding from the  
9 California Commission on Peace Officer Standards and Training; and

10 WHEREAS, The California Commission on Peace Officer Standards and Training  
11 awarded SFPD \$185,424 to support the development and Peace Officer Standards & Training  
12 (POST) certification of a Limited English Proficiency Training course under a distance learning  
13 environment for law enforcement personnel for the project period beginning October 15, 2020,  
14 and ending on June 30, 2021; and

15 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

16 WHEREAS, The grant budget includes provision for indirect costs of \$265; now,  
17 therefore, be it

18 RESOLVED, That the Board of Supervisors authorizes SFPD to accept and expend the  
19 grant of \$185,424 the California Commission on Peace Officer Standards and Training to  
20 support the development and Peace Officer Standards and Training (POST) certification of a  
21 Limited English Proficiency Training course under a distance learning environment for law  
22 enforcement personnel; and, be it

23 FURTHER RESOLVED, That the Board of Supervisors authorizes the Chief of Police,  
24 or his designee, to enter into the agreement on behalf of the City and County of San  
25 Francisco; and, be it
